RE: Manuscript Tracking Software

Greg asked me to revisit the information on Manuscript Tracking Software. I've included some information on multiple systems below.

MS Tracker Software

- Web-based submission of manuscripts, cover letters, abstracts and reviews
- Ability to send reminders, decisions, review requests
- Reporting functions: outstanding reviews, turn around time
- Email notification of significant manuscript actions (submissions, reviews, declined reviews)
- Scalability
- Real-time author access to manuscript status
- Menu-driven interface
- Free version upgrades and unlimited e-mail support

Cost -- Per manuscript: \$10

- A 30-day free trial is offered during which an editor can accession any new, awaiting revision, and under review manuscripts at no cost.
- Service includes unlimited e-mail support and version upgrades.
- o Deployment of the turnkey system usually takes one business day.
- Submission portals are available at no cost or obligation. Charges are incurred for accessioned manuscripts only.
- No cost for Revised submissions, no cost for set up and no cost for maintenance fees. Pricing structure is very simple.

If the list of journals on the "History –Status Report" is accurate (there isn't a list of users, and the list of journals could be fictional), then there seem to be a lot of science and medical journals using this process.

Modules

 Administrator: Administrators have access to all manuscripts and possess the most function-dense office type. Their primary duties are the accessioning of manuscripts, maintenance of author and reviewer records, sending of review requests and reminders, and proofreading before the sending of decision and thank-you letters. Manuscripts can be processed entirely from within the administrator's office.

- Main Editor: Main editors have access to all manuscripts. Their primary duties are the
 assignment of newly-accessioned manuscripts to an associate editor (or to themselves),
 identification of reviewers to solicit regarding manuscripts to which they are assigned,
 and composition and approval of decision letters.
- **Associate Editor:** Associate editors have access only to manuscripts to which they have been assigned. Their primary duties are the identification of reviewers to solicit regarding their manuscripts and the composition of decision letters.
- All Offices: All offices have access to various reports and the ability to send and re-send review reminder and thank-you letters. They also have the ability to update the template letters associated with their respective offices. In the case of associate editors, data is limited to manuscripts to which they have been assigned.

Manuscripts may, but are not required to, pass through the following status categories. The user whose Action Needed Display presents the manuscripts in each category is stated in parentheses, where applicable.

- New Submissions/Needs Accessioning (administrator)
- New Submissions/Needs Accessioning Completed (administrator)
- Record Created/Needs Editor Assigned (main editor)
- Editor Assigned/Needs Reviewers (assigned editor)
- Reviewers Identified/Needs Requests Sent (administrator)
- Out For Review (see Outstanding Reviews report menu option)
- Reviews Returned/Needs Decision Letter (assigned editor)
- Decision Letter Created/Needs Editor Approval (main editor can be sent directly if a final proofread by the administrator is not desired)
- Decision Letter Approved/Needs Sent (administrator if the main editor desires a final proofread)
- Accepted/Forms & Final Version Pending
- Accepted/Forms & Final Version Received/Publication Pending (see Compile Issue menu option)
- Awaiting Revision
- Rejected
- Withdrawn
- Previous Versions of Re-submissions
- Published

No published software reviews that I can find.... No rankings. Seems a bit clunky, but functional. I'm sure that working with it would make it seem more "user friendly"

Pricing:

Two versions are available—PeerTrack Essentials is the basic version – fewer than 200 MSS per year. PeerTrack is more broadly customizable and much more expensive.

For PeerTrack Essentials

Flat one time set up fee: ~\$1500

Per manuscript fee: ~\$30 (can select out MSS that do not apply)

They would do a live demo prior to signing a contract, and the fees may change based on needs identified during the demo.

BePress EdiKit

A digital commons solution for full journal publication, which may be more than we need. In addition to managing editorial workflow through tracking manuscripts, it allows hosting, publication, discovery, and other functions.

Workflow management includes

- Manuscript tracking
- Oversight of referee activity

- Management of correspondence with editors and authors
- Versioning

No information on pricing. With relatively little information available online, I wonder if "EdiKit" is available OUTSIDE of a Digital Commons license? They imply that the editorial management system "comes with" the license, but I'm guessing that the two cannot be separated. I believe that this is more product than we need or want at this time, based on our ongoing relationship with MetaPress.

Bench>Press Manuscript Tracking

Web-based manuscript tracking and management service. There isn't a great deal about the system itself. There is an implication that HighWire is involved in assisting in peer review — "High Wire believes that scientists and editors need tools to assist with the intellectual portion of manuscript management: making judgments about who could best interpret a paper, about where it fits in the network of discoveries, etc. HighWire is uniquely positioned to implement tools that leverage the literature base, with extensive experience in electronic publishing and online hosting." So while the product seems to provide the manuscript tracking that we're looking for, the STM focus and the implication that they insert themselves into the editorial process makes me hesitant to pursue them as a viable option.
