Social Media Update - Eric Chin

BAS now has a presence on Facebook and LinkedIn! BAS pages currently have 47 "Likes" on Facebook and 59 members on LinkedIn. Both sites offer detailed metrics on which postings spark the most interest and attention. Currently Eric and others have used the sites to share job postings, news items, other relevant inquiries and discussion. The membership has reacted positively and we continue to see how people engage and respond. Eric expects to see more social media members and activity as we move closer to the Annual Conference.

The BAS social media initiatives are a potential topic for the Colloquium, or more likely the Section Business Meeting.

Eric will send reminders about the social media sites and call for newsletter submissions to the membership. He will emphasize that the Facebook page is open and accessible to anyone, even those who don't have personal accounts (or can't/don't want to login).

2013 BAS Colloquium Planning – Steve Hausfeld / Scott Grimwood

The Colloquium will most likely be held in the Conference hotel as Steve has not been able to find a workable alternate venue. Scott will notify SAA to reserve space at the hotel.

For the post-Colloquium social, Steve has proposed Tommy's Cuisine (http://www.tommysneworleans.com/), a restaurant recommended to us by Ted Ryan of Coca-Cola.

Pros: Tommy's will not charge for use of the room or require an up-front deposit. It is also close to the hotel, which is an important consideration during the heat and humidity expected of August in New Orleans.

Potential concerns: Price point is somewhat high and the menu is predominantly seafood. If appetizers are ordered for the group, the Committee will make sure to include some non-seafood options. Committee members observed that attendees often use the social as an opportunity for drinks and networking before heading elsewhere for dinner.

There is still time to explore other venues for the social, but Tommy's proximity to the hotel and lack of a room charge make it an attractive choice.

Other Business

Down the road, Scott would like to explore modifying the Co-Chair's numerous responsibilities to share some of them among other Steering Committee members.

Nicole offered to support other Steering Committee members as needed. Steve enlisted her to assist with Election business. The Steering Committee will also need more help from Memberat-Large as the Conference draws nearer.
