AASLH Corporate History Affinity Group Collaboration - Scott Grimwood

Scott met with Tiffany M. Meng, Director, Delta Air Transport Heritage Museum, in Atlanta. Tiffany leads the AASLH Corporate History Affinity Group. CHAG organizes corporate history tours and a session at the AASLH annual meeting. Scott and Tiffany discussed ways BAS and CHAG might collaborate in the future, such as publicizing each other's events or tapping members to develop shared programming. We believe there is overlap but don't know how many BAS members also belong to CHAG.

Sue Topp recommended that CHAG be invited to send a representative to the BAS annual business meeting to provide an overview of CHAG to BAS members.
