#### **F. Case Studies**

Open-access content in the form of case studies published on the SAA website continues to grow. The Publications Board is now partnering with several component groups to review and publish this type of content. The College and University Archives Section recently took over soliciting content for Campus Case Studies, which were first published in 2008 and serve as the model for case study production with sixteen cases available online. The Committee on Ethics and Professional Conduct has published four case studies since going live last year and the Diversity Committee is evaluating content. In late spring the Government Records Section issued its first call for case study proposals.

#### **G. Archives Short Fiction Contest!**

It's the first-ever fiction contest sponsored by the Publications Board. The story must feature an archives, an archivist, or archival materials and be no more than 3,000 words. The winning entry will be posted on the SAA website. The deadline is Oct. 30. Get writing!

## **II. PERIODICALS**

### **A. *The American Archivist***

- **Reviews Editor Transition . . . Thank you, Amy Cooper Cary!**

As a result of her election to the Council this year, the Editorial Board bids adieu to Reviews Editor Amy Cooper Cary, who was first appointed to the post in 2010 and was in the middle of her second term. In addition to editing many splendid book reviews, nurturing new voices, and preparing the often-cited writing guides on "How to Write a Book Review" and "How to Write a Web Review," Amy established the Reviews Portal on the SAA website. The portal complements the print edition by providing additional reviews that highlight websites, digital collections, and technologies which have an impact on the archives profession. It also provides more immediate access to reviews that appear in the print edition of the journal as well as lists books published by SAA members. Amy

also served on the Online Publication Working Group, which recommended the new publishing platform for the journal. Thank you, Amy!

**. . . Welcome, Bethany Anderson!**

The call for applications for a new Reviews Editor was initiated in May and closed on July 20. Five strong applications were received and phone interviews were conducted with all applicants. Bethany Anderson has been appointed to the post and will begin a three-year term in August. She is the archival operation and reference specialist in the University Archives at the University of Illinois at Urbana-Champaign. Bethany is familiar with SAA's publishing program: she contributed a case study to *Module 8: Becoming a Trusted Digital Repository* by Steve Marks, was a member of the Online Publication Working Group, and served as an intern on the Publications Board. The search committee was chaired by the journal's editor Greg Hunter and included SAA staff Teresa Brinati and Anne Hartman. Welcome, Bethany!

- **Allen Press**

The first stage in the implementation process for the new publishing platform is nearing completion. The new website—[AmericanArchivist.org](http://AmericanArchivist.org)—was launched in late April with improvements made throughout the summer. Legacy content was migrated from MetaPress, DOI applied to those articles, and CrossRef citation linking activated. SAA members and journal subscribers received an email from Allen Press in late spring inviting them to register as a user, which makes accessing and logging into the system easier. New features include favorites and email notification. There have been a few display hiccups—adding covers for every issue, fixing erroneous metadata migrated from MetaPress, adjusting page numbering and re-ordering content within issues—but Allen Press has readily addressed infelicities. Quality assurance is also in progress. SAA provided Allen Press with a series of spreadsheets listing every article in every issue to be compared against migrated content. Any missing files will be identified and supplied by JSTOR as the SAA Archives has purged the DVDs from the original digitization done in 2007.

The second phase of implementation began in July when content from the Spring/Summer 2015 issue was converted to HTML5 and posted to [AmericanArchivist.org](http://AmericanArchivist.org). Composition and printing transfers to Allen Press with the Fall/Winter 2015 issue. Page templates and other production-related details are currently being reviewed.

The third phase of the implementation will begin this fall and should take approximately three months. It involves introducing PeerTrack, a system unifying the submission, tracking, review, and editing of manuscripts. It's quite an exciting development that will save time, add a measure of transparency, and lay the foundation for an XML workflow.

## **B. Archival Outlook**

Editorial and Production Coordinator Anne Hartman reports that there have been 8,072 total issue visits and 5,485 monthly unique issue visits to *Archival Outlook* digital editions and 42,793 unique page views in 2015. The most-visited articles in the May/June 2015 issue include “Crowdsourcing Memories: Developing a Crowdsourcing Model for Collection Development and Description” by Natalie Baur and “Wikipedia, Gender, and Archives: Closing the Gender Gap on Wikipedia through Archival Outreach” by Chloe Raub. Printing of *Archival Outlook* was recently moved to Source4—the magazine's distributor—to enhance production turnarounds.

### C. *In the Loop*

Anne Hartman reports that there are now 8,347 subscribers to *In the Loop* (members and nonmembers). The open rate continues to hover around the industry average of 22.95 percent. Some of the top clicked-on blurbs include “SAA Names 2015 Fellows and Award Recipients,” “Take the First High-Stakes Archival Essay Test,” and “Module 8: Becoming a Trusted Digital Repository” (prepublication special).

### D. Social Media

SAA’s following on Twitter and Facebook continues to grow, according to Anne Hartman. SAA now has 7,682 Facebook likes (up from 7,036 in January 2015) and 8,550 Twitter followers (up from 7,564 in January 2015). Some of the top Facebook posts include:

## III. DICTIONARY WORKING GROUP

Word of the Week celebrated its first anniversary in July and crossed the four-digit threshold in number of subscribers with 1,004 recorded at the end of the month. Open rates vary between 35% and 50% (the nonprofit industry average is 22.83% according to MailChimp). The terms with the highest open rates were *bone folder*, *Bertillon card*, *recordness*, *tag*, and *hydrolysis*.

Collaborative editing, publishing, and maintaining the new *Dictionary of Archives Terminology* requires specialized software. The working group investigated software last year and will be moving forward with a purchase this fall so it can begin to build this important resource.
