Hi Teresa,

Many of MetaPress's publishers are also partnered with EBSCO Publishing, so this is by no means an unusual request! While we'll be hosting your content, EP would place you into relevant EBSCO databases to give you wider visibility. You do get to decide how much content EP will make available via

their databases, which is something to think about and talk over with EBSCO. For example, some of our publishers use embargoes so that EP is not allowed to display any current-year content. You'll need to let MetaPress know what content you want exported to EP, and you'll need to work out an agreement with them regarding how much they're allowed to display. So, the database could display some of your older content, but users would be linked to MetaPress if they tried to access your current content (assuming you use an embargo), for example.

I don't think there would be dilution by agreeing to such an agreement with EBSCO—it could (and should) increase your visibility among academic researchers.

Please let me know if the above is useful, or if you'd like me to try to dig up some more information!
