The ADA is a wide-ranging civil rights law that prohibits, under certain circumstances, discrimination based on disability. Signed into law in 1990 and amended in 2008, Title II of the ADA prohibits disability discrimination by all public entities at the local and state level. These regulations cover access to all programs and services offered by the entity, including physical access described in the ADA Standards for Accessible Design.
