B. Exciting Development: ARCHIVAL FUNDAMENTALS SERIES III

The Publications Board has begun to lay the foundation for the Archival Fundamentals Series III with projected availability starting in 2017. Like its predecessors, the series will be the bedrock of the publishing program and will represent SAA's intellectual capital. Each volume will support SAA's strategic goals: advocating for archives and archivists, enhancing professional growth, advancing for the field, and meeting members' needs. The series editor will be Peter J. Wosh, director of the Archives/Public History Program at New York University. II. DICTIONARY OF ARCHIVES TERMINOLOGY

Engaging the professional community in the identification and development of new terminology and the review of existing terms has been a chief focus of the Dictionary Working Group, which is building the new *Dictionary of Archives Terminology* (coming 2015). On July 23, Word of the Week was launched. This weekly e-blast now has more than 700 subscribers and is designed to introduce new terms and definitions as well as get feedback. Social (#SAA words) and other media also are being used in this effort. A revised form (“Suggest a Term”) has been added to the SAA website. During the joint conference, DWG is hosting a breakfast forum and a “Define This” sticker promo to raise awareness about the dictionary and to encourage participation in its development.

III. PERIODICALS

A. *The American Archivist*

In early April, SAA received a termination notice from MetaPress, the hosting service since 2007 for *The American Archivist Online*. The online content will be accessible without interruption or adverse effect through January 28, 2015. In the meantime, an SAA group has been assembled to re-examine the journal’s digital direction with regard to the new strategic plan and identify a solution. Chaired by Paul Conway (co-chair of the 2007 online investigation) and consisting of Amy Cooper Cary (Journal Reviews Editor), Brad Houston (SAA Archives), Bethany Anderson (Publications Board) and SAA staff, the group reports to the Editorial Board, which will make a recommendation to the Council this fall. In July, the group issued RFPs to 14 prospective vendors. Proposals are due August 29 and will be evaluated in September.

B. *Archival Outlook*

Last winter the digital edition of *Archival Outlook* was launched using BlueToad. There no longer is an embargo on recent issues—*AO* is open to all. The magazine has enjoyed a significant increase every month in issue visits and time spent per issue visit. According to BlueToad analytics, between February 1 and August 4 there were 13,610 total issue visits with a peak of 8 minutes spent per issue visit!

C. *In the Loop*

The new mobile design debuted in the spring has been well received by readers. Open and click rates are the highest they’ve been. Open rates have tipped 27% (that’s the percentage of membership who open the email), while the click rates have hovered at 12% (the percentage of readers who click on a link in the email). According to MailChimp (the service used to send the biweekly e-blast), the nonprofit industry average for open rates is 23.5%. *In the Loop* is above average!
