Over the past several months, SAA's book publications program and the Publications Board have been very active, with several projects moving forward expeditiously and new projects being proposed; these are detailed below. I will spend significant amount of effort in the upcoming months editing this work, as well as soliciting new proposals, and leading the board in assessing new business models, following up on discussions from our February 2015 meeting.

I am very pleased that the board is actively engaged in the work of the publications program, offering substantive comment on proposals and advice as 'shepherds' for book projects, among other activities. In addition, the board receives excellent support from Director of Publishing Teresa Brinati and Editorial and Production Coordinator Anne Hartman. I would like particularly to acknowledge the outstanding contributions provided by departing board member Cheryl Oestreicher, Council liaison Michelle Light, and intern Cara Bertram and to bring their contributions to Council's attention.
