
## Abstract

Research constitutes a structured approach to understand and address problems in a field. An essential component to research is the ability to share the results of those efforts to the larger community in order to increase collective knowledge. The Research Forum has served this function for the past ten years. But what is being covered over those ten years? This poster represents an analysis of the overall topic distribution at the Research Forum since its beginning with a comparison to a larger research project completed five years ago and presented at the Research Forum. It also looks at topics in the Arrangement and Description category. Specific topics are identified and trends are discussed.

## Research Forum Topic Distribution



## Trends

Arrangement and description topics have appeared in each year of the Research Forum. Early explorations focused on the efficiency of record creation and ways to serve up description in various environments. The digital or electronic record dominated format considerations although other formats also presented challenges to be addressed.
