BACKGROUND

At its winter meeting each year, the SAA Council elects three individuals to serve on the Committee on the Selection of SAA Fellows. The Committee is composed of the five most recent past presidents of the Society and three Fellows who are elected by the Council. Past presidents, current members of the Council, and Society staff members are not eligible for election. Per a change in procedure adopted at the February 2010 Council meeting, the past president who has served longest on the Committee serves as its chair. It is permissible for elected Fellows to serve on the Committee more than once.
