Staff Report: Education

Please note that the following report includes both the staff report (August 2013 to January 2014) and the Committee on Education Annual Report.

Staff Report, August 2013 to January 2014

- Scheduled 101 programs.
- Offered 61 face-to-face programs.
- Delivered education to a total of 1,211 attendees.
- Cancelled two courses and two workshops.
- Postponed four courses.
- Worked with 13 new hosts.
- Scheduled DAS comprehensive examinations in 15 locations.
- See Table for details on FY14 schedule.

DAS Certificate Program

- Contracted for one new course, "Processing Digital Records and Manuscripts," a webinar based on the *Module 2: Processing Digital Records and Manuscripts* e-publication (Daines).
- Revisions/updates in process:
 - Premis Tutorial
 - ViewShare webinar
 - Standards for Digital Archives webinar
 - Achieving Email Account Preservation with XML

DAS Participation

- 961 individuals have attended DAS courses in FY 2014.
- 600 individuals (as of 1/5/14) are pursuing the DAS Certificate and have taken exams.
- 55 individuals are at the six-course threshold.
- 14 individuals have fulfilled all requirements and were awarded the DAS Certificate.
- 35 individuals took the comprehensive examination in November.

DAS Comprehensive Examination Schedule

- August 2013 in New Orleans (15).
- November 2013 in Austin, Boston, Chicago, Cheney, WA, Minneapolis, Nashville, and Provo, UT (35).
- February 2014 in Austin, Boston, Chicago, Fairfax, VA, Los Angeles, New Orleans, and New York.

Other: Hired Mia Capodilupo as Education Coordinator.

DAS Subcommittee

- During its October 21-22, 2013, meeting, the group reviewed the final DAS statistical report provided by Dr. Sandy Dolan (SAA's psychometrician) to determine the pilot items needing revision or deletion from the comprehensive examination. The final examination resulted in a passing grade for 14 of the 15 exam takers in New Orleans. Looking forward, the committee will continue to create and add sets of 10 pilot questions to the examination (each time it's scheduled) to be evaluated for addition to the exam pool.
- Agreed to focus on webinar training and management of expectations for development and start review on existing courses in accordance with the two-year maintenance cycle.
- Use the SAA YouTube channel to create and add 60-second videos to the DAS website that are composed of simple, animated PowerPoint presentations about the DAS Certificate Program.
- Communicate with students via tutorials that show step-by-step how to download software needed for courses, etc.
- Worked on checklist/guidelines for new and current instructors.
- Made two recommendations to the Committee on Education: 1) to expand the Subcommittee by two more members; and 2) to extend the terms of current members to five years to ensure continuity.

Committee on Education (COE) Report, August 2013 to January 2014

At its August meeting in New Orleans, COE received various updates on Council decisions, affirmed comprehensive examination policies recommended by the DAS Subcommittee (DAS SC), and conducted a two-hour DAS faculty session.

In October COE members started to join the monthly calls held by the chair, vice chair, Council liaison, and staff. Resulting actions included:

- Approval of the DAS SC recommendation to expand the subcommittee by two members and the tenure of current (as of August 2013) members to five years to ensure continuity. Submitted recommendation to the SAA Council. (See 0114-III-G-DASSubcomm.)
- Agreement on a timeline for review of the courses/workshops that should be included in an Arrangement and Description track. COE members will share and discuss their findings at the March meeting.
- A meeting with Publications Chair Chris Prom, COE Chair Jamie Roth, and staff members Teresa Brinati and Solveig De Sutter to discuss ways in which SAA's Education and Publications programs might collaborate. Specifically, what courses, workshops, or webinars would be suitable for production of a corresponding print or e-publication and, conversely, what print or e-publications could be developed into courses, workshops, or webinars. A DAS webinar based on Gordon Daines' *Module 2: Processing Digital Records and Manuscripts*, was identified as "low hanging fruit" and is under development.
- The DACS workshop has been revised and is still undergoing tweaks. Additional workshops and webinars are under discussion.
