Introduction

With this report, I mark the completion of my second year as editor of *The American Archivist*. It is an honor and a privilege to serve SAA's membership and the archival profession in this capacity.

Upcoming Issue

I have finalized the content for Volume 77, No. 1 (Spring/Summer 2014). My working table of contents is attached to this report (Appendix). Over the next month, I will be working on the copyediting of this issue.

Peer Review

Since January 1, there has been a steady flow of article submissions. I have been pleased with the quality of the articles and the professionalism of the peer reviewers.

I received a total of 54 articles this year, 39 new ones and 16 that were revised after originally being submitted in 2012. The disposition of the new 2013 articles was:

Since the "revise and resubmit" category is now the largest, I am providing additional analysis of it. At some point in 2013, 52 different articles were in the "revise and resubmit" category.
