I. QUARTER HIGHLIGHTS

- American Archivist 87.2 released late December.
- Our online Winter Book Sale was a success, running over a two week period with sales of nearly 100 books totaling \$2,682. We also have two new books scheduled to release Q1 of 2025: Trends in Archives Practice: Providing Access to Privacy Protected Records at Public Institutions in the Age of Radical Empathy, and Archival Fundamentals Series III, Volume 6: Selecting and Appraising Archives and Manuscripts.

V. DICTIONARY OF ARCHIVES TERMINOLOGY

- The <u>Dictionary of Archives Terminology</u> continues to be updated to reflect improvements to definitions based on user feedback as well as introduce new terminology. The nine-member working group meets every Wednesday via Zoom to define terminology and draft the <u>Word of the Week</u>.
- Platform training is ongoing post-migration.
- SAA has set up access to a backlog of SAA publications accessible by DWG members for ease of access in citations for new terms.

- a. Late fall into winter constitutes a busy time for various calls and initiatives. These are tracked by SAA staff and are disseminated via news releases, emails, social media, and SAA Connect.

- D. More targeted messaging was used to reach different sub-groups of SAA's mailing list. We continue to refine this process to create a better messaging experience for our members.

III. Communications Procedures Reminder

- a. SAA produces a large amount of content each month, from procedural updates to statements to professional information. Given those constraints, we ask the following when a statement is planned to be released:
 - I. Please ensure the statement is finalized prior to being shared with staff for release. Information, structure, and sentence-level changes should be finalized.
 - ii. Staff will review the statement for clarity. Minor grammatical errors (correcting capitalization, commas, etc.) will be made by staff. Anything

- that requires larger clarification will be run past the body releasing the statement prior to the statement being released.
- b. The goal of these guidelines is to minimize confusion and duplication of work and streamline the publication process.
