Archival Fundamentals Series II

At our February meeting, the Publications Board considered options to update and/or reconceptualize the AFS II series. We had a good discussion and the board made several recommendations. I am currently working to develop a vision for the series. Additional information regarding our plans will be announced this summer.

Additional Activities

Case Studies Series: Over the past several years, several SAA groups and individuals have

contacted the Publications Board for assistance in editing and publishing freely-available case studies on the SAA website. Working with CEPC chair Nancy Freeman, the board developed a process and peer evaluation framework for groups to use in developing such projects, based largely on the *Campus Case Studies Series*. The project is currently in “soft rollout” with CEPC and other groups. Further information about this exciting initiative will be announced to the members this summer.

Dictionary Working Group: Margery Sly has agreed to serve as Publications Board representative and has been actively contributing to the group.

Licensing: At its January meeting, the Publications Board discussed licensing options for e-publications; possibilities are being investigated by SAA staff.
