Society of American Archivists Council Meeting July 26, 2023 Hybrid Meeting – Washington, DC

Treasurer's Report (Prepared by Cherie Newell, Operations Director)

Overview

For the month ending January 2023, SAA posted a net loss of \$ 6,649. This is a *favorable* variance of \$30,377 (82.04.14%), as the budgeted *loss* for January was \$37,026.

Total revenues as of January 30 were higher than last year by \$249,983 (17.19%) and short of budget by \$182,362 (9.65%). Total expenses were higher than last year by \$381,312 (28.62%) and lower than budget by \$212,740 (11.04%). The variance in budget reflects the timing of expenses in some cost centers and savings due to staff turnover.

Balance Sheet

As of January 31, 2023, Cash and Investments balances were lower than last year by \$91,443 (5.07%), and total deferred revenues were *lower* than last year by \$1,641 (.24%). Our Cash and Investments balance has slightly declined from our prior period balance for FY 2022. Membership and Subscription deferred revenues are slightly lower than the same time last year.

Income Statement

For the month ending January 31, 2023, SAA posted a net loss of \$6,649. This is a lower net loss than last year, by \$131,328 (105.33%). Total revenues as of January 31 were higher than last year by \$249,983 (17.16%) and behind budget and by \$182,362 (9.65%). Total expenses were higher than last year by \$381,315 (28.62%) and lower than budget by \$212,740 (11.04%). The variance in the budget is due to the timing of revenues in Education and expenses in several cost centers. Specific points of interest are as follows:

- Membership: Total membership as of January 30 was 5,512, and dues revenue was ahead of last year by \$11,620 (2.03%) and *better than budget* by \$4,001 (0.69%). Membership's net gain as of January was \$10,372 (1.80%), better than last year. Membership deferred revenues in January were \$ 554,644 (.55%) higher than last year's.
- Annual Meeting: As of January 30, 2023, the 2022 Annual Meeting showed a net gain of \$66,541, lower than the budgeted estimate of \$117,622 by \$66,541 (43.43%). While we budgeted for 1000 Virtual and 875 In-person (1,875) attendees, we have realized about 1,777 total registrations thus far. Revenues for the conference fell short of budget estimates by \$89,456 (12.60%), and expenses are \$22,098 (3.74%) lower than budget. The

revenue shortfall compared with the budget is largely the result of shortfalls in Exhibitor and Sponsorship revenues. Exhibitor revenues totaling \$86,259 were \$27,741 (24.33%) lower than budget estimates, and Sponsorship revenues of \$43,350 were \$21,650 (33.31%) lower than budget estimates. Altogether, this shortfall represents 60% of the budgeted revenue shortfall for the conference. The expense savings are largely the result of savings on staff salaries. In addition to a \$15,000 rebate received from hotel attrition.

- **Publications:** Publications posted and net loss of \$ 50,869 for the period ending January 31, 2023. This is a greater net loss than last year and by budget \$7,920 (18.44%) and \$2,423 (5%), respectively. Revenues are well short of last year and budget by \$ 15,348. (21.74%) and \$30,682 (35.7%), respectively. Overall, Publications is 5% short of budget estimates through January 31, 2023.
- Education: Education posted a net gain of \$29,559 for the period ending January 31. This is behind last year's budget by \$86,860 (74.61%) and \$59,801 (66.92%), respectively. Total revenues fell short of budget estimates by \$108,535 (31.71%) and expenses were under budget by \$48,733 (19.27%). The lighter course schedule in the first few months of the fiscal year has resulted in Education performance lagging behind straight-line budget projections.
- **Career Services:** As of January 31, Career Services posted a net gain of \$45,126, which is better than last year and budget by (65.69%) and (65.59%), respectively. Revenues totaling \$72,209 exceeded last year's budget by \$18,290 (33.92%) and \$19,392 (36.72%), respectively. Our Career Center budget estimates for FY23 assumed a return to trend line budgeting in the assumption that the job market is relatively stable. The employment outlook for the types of organizations that post on the SAA Career Center job board is vital.
- General and Administrative: The net loss in G&A for the period ending January 31, 2023, was \$ 349,304, which is a smaller net loss than last year and budget by \$24,200 (6.48%) and \$54,329 (13.46%), respectively. The variance with last year and budget is largely a result of the timing of audit and consulting expenses and savings due to staff vacancies. Delays in expenses in this program have helped offset losses from the Annual Meeting and Education programs.
