## Society of American Archivists Foundation Board of Directors Meeting November 13–14, 2016 Chicago, Illinois

## **Executive Director's Report** (Prepared by Executive Director Nancy Beaumont)

Since the Foundation Board's August 2016 meeting, the staff office have accomplished the following:

- Conducted an online discussion and vote by the SAA Council to elect the slate of Class B nominees put forward by the Foundation Board. We then notified the newly elected Class B members and updated all rosters and lists.
- At the suggestion of Carla Summers, we sent a letter from Foundation President Fynnette Eaton to all exhibitors at the 2016 Joint Annual Meeting. (See the President's Report at IV.A.)
- Implemented all accounting and marketing changes associated with the Board- and Councilapproved consolidation of funds. Revised the Foundation's online donation form at
  <a href="https://saa.archivists.org/4DCGI/donate/form.html">https://saa.archivists.org/4DCGI/donate/form.html</a>. And sought testimonials from scholarship
  award winners and our 2016 grant recipient to begin development of more engaging content
  for the website.
- Based on the Board-adopted <u>Development Plan</u>, drafted a general actions list and a communication plan for Foundation appeals from November 2016 through December 2017. (See Agenda Item III.C.)
- Drafted the 2016 year-end annual appeal communications for review by the SAA and SAAF presidents and Annual Appeal Committee members Waverly Lowell and Larry Gates.
- Attended a webinar on #GivingTuesday to gather ideas, tips, and tricks for implementation of the Foundation's event on Tuesday, November 29.
- Had several phone and email communications with a potential multi-year sponsor of the Mosaic Scholarship. I will update the Board at this meeting.
- Prepared the September-end financial statements. (See Agenda Item IV.B.)

- Placed simple messages about the Foundation's grant funding program in the September 14, September 28, October 12, and October 26 issues of *In The Loop*. The two messages that have run thus far:
