#### **Certificate Program Updates**

- 26 DAS Certificates were awarded during the September exam cycle. 12 people renewed their DAS Certificate this quarter. One year ago, we saw 27 people earn the DAS Certificate and 8 people renew in Q1.
- One person earned their A&D Certificate this period. There were no renewals. This time last year, 6 A&D Certificates were awarded, alongside one renewal.
- The Option B renewal option for the DAS Certificate launched in March for a two-year pilot through March 2027. 2 people applied for Option B in Q1 of FY26.

#### **Highlights and Discussion**

- Education provided A&D of Digital Records as a closed course to staff from the Library of Congress in July 2025.
- CoE, had a productive conversation with leadership from the C&U section about possibilities for collaboration on a program addressing challenges faced by the archival community.
- SNAP invited SAA Education staff, DAS, and CoE to participate in a panel conversation about the DAS and A&D programs in January 2026.
- Education continues to offer four career webinars free of charge to federal archivists terminated due to federal layoffs and budget cuts in 2025. As of this writing, 27 people have taken advantage of this content.
- One of our longstanding DAS courses, Web Archiving Fundamentals originally created in 2015, was revised and launched this quarter. The DAS Subcommittee is making recommendations to staff about high-priority webcast revision projects we can undertake in the remainder of FY26.
- A brand-new course, *Records in Context, in Context*, is planned for Fall 2025, as an addition to the A&D Certificate curriculum.
