Updates (if any)

Co-chairs (Lara and Dan)

- Update: Collection Management Section likely to take on the Joint Guidelines for Standardized Holdings Counts and Measures for Archival Repositories and Special Collections Libraries. Dan will draft a proposal for Council.
- Update: Have not heard back from the Archives Management Section about taking on Best Practices for Volunteers in Archives (currently maintained by the Committee on Education's Graduate Archival Education subcommittee) and Best Practices for Archival Term Positions.
- RiC updates (Dan)
 - There was previously discussion about creating an International Standards Coordinating Subcommittee to try and improve relations between EGAD and SAA (it even found its way into a proposed governance manual revision).
 - We (the TS-EAS and Standards co-chairs) think this proposed group would be counterproductive. Lydia will make sure it is removed from the revision to the governance manual.
 - Discussion of EGAD's place in ICA
 - TS-EAS feels confident they can handle the relationship
 - There is currently no representative from EGAD to Standards or from SAA to EGAD (the latter has never existed). It is not clear whether either role will be filled in the near future.
 - Call for volunteers garnered some interest but unclear when this will be filled.
 - At this time, the only work going on relating to RiC is in the subcommittees.
 Standards is available to provide support as needed.

Council (Lydia)

- Council finalizing governance manual revisions
- Finalizing talking points about ethical investments, statements re federal government, set up two working groups to address current political landscape, Lydia on a subgroup digging into Project 2025, other is about generating statements in a more timely fashion
- Upcoming Council deadlines

Technical Subcommittees (liaisons to)

TS-DACS (Dan)

- <u>Developed a method</u> for submitting comments on Github pull requests without needing to register an account
 - Will use a dummy email address to automatically add comments to Github.
- Preparing to bundle multiple pull requests into a single call for comments soon

TS-EAS (Lara)

- TS-EAS met on Zoom on Feb 26/27
 - TS-EAS has been engaged in a process of aligning the revisions of its standards so they can coordinate and work collectively and better respond to RiC. The revision cycles are now aligned and now they are moving into next steps.
 - Discussion of issues with Annual Meeting, which TS-EAS normally holds in person but still has no clear commitment of funding from SAA Council, which has not taken up the issue (though the request was sent in in October).
 - The group is in the process of deciding whether to do the meeting online and is soliciting feedback from its members
 - Lara wil Ireach out to Karen to see if they want Standards to have Lydia intervene
