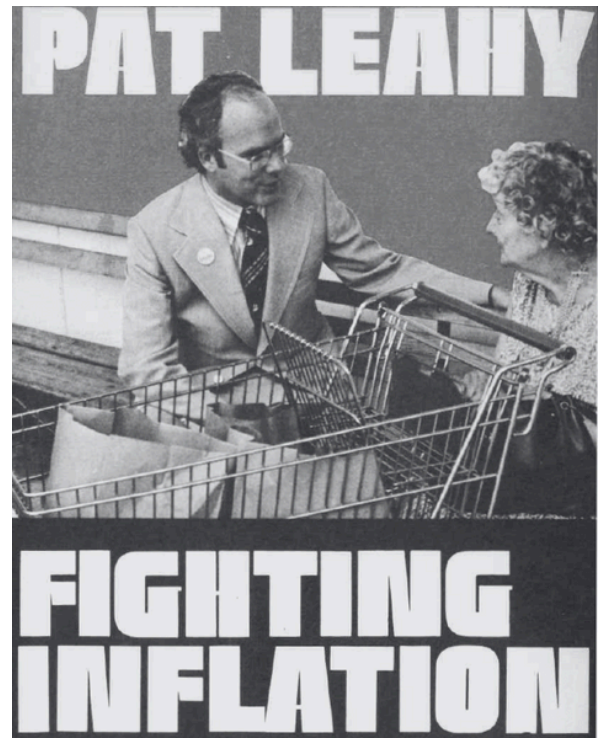
Collection Update: Senator Richard Burr

Wake Forest University has received the political papers of Senator Richard Burr. Richard Burr was a U.S. Representative from 1995-2005 and a Senator from 2005-2023. He was the Chairman of the Senate Intelligence Committee from 2015-2020, and some of his legislative accomplishments include the FDA Modernization Act of 1997, the Pandemic and All-Hazards Preparedness Act, and the creation of the Biomedical Advanced Research and Development Authority. Project archivist Kate Trathen has been working to process the Richard M. Burr Congressional Collection since January 2023. As the project enters its third year, significant progress has been made. Processing of the physical collection, including memorabilia, is on track to be completed by the end of the academic semester. Processing work on electronic records is ongoing—one series (press files) is nearing completion, with significant work being done on digital photos and legislative files as well. Some digitized videos are already available online as part of our [digital collection](#). We do not have a release date for the rest of the collection yet, but we are anticipating that it will be ready and open for research by the end of 2025.

Also of note was a recent trip to Washington, D.C. Kate Trathen and Tanya Zanish-Belcher, Director of Special Collections and Archives at Wake Forest, gave two talks in conjunction with Dina Mazina, Deputy Archivist and Records Management Training and Services for the U.S. Senate. We talked about our work on the Richard Burr Congressional Collection and other experiences with political papers. Thank you, Dina, for lending your expertise to our panel!

Collection Update: Senator Patrick J. Leahy

The University of Vermont Silver Special Collections Library has released the first two series of the Senator Patrick J. Leahy Papers for public access. Senator Leahy (D-VT) is Vermont's longest-serving U.S. Senator and the third-longest serving senator in American history. The papers document the work of his office and 1300+ staffers over the course of his 48-year career, spanning 1975-2023. This first part of the collection includes materials from the Senator's travels and congressional delegations as well as his eight election campaigns. Consisting of approximately 3000 boxes of records and 20 terabytes of digital material, the collection is being processed by project archivists Shir Bach, Sally Blanchard-O'Brien, and Erica Donnis with a five-year \$2.5 million Preservation Partnership Grant funded by the United States Senate Historical Office. The grant includes substantial funding for student internships and will provide more than 50 undergraduates with experiential learning opportunities that introduce them to archival work by the end of the project. CPS Meetup details

Friday, April 4, was our first virtual meet-up of 2025 discussing campaign documentation. We had six speakers: Dina Mazina (U.S. Senate Historical Office) talked about the rules separating official work from campaign work and thus the challenges and limitations in capturing campaign materials; Sara Stefani (Indiana University) discussed donor relations and collection guidelines for what campaign material to take and what to decline; Shir Bach (University of Vermont) walked us through the processing campaign records; Sally Blanchard-O'Brien and Erica Donnis (University of Vermont) shared their experience using campaign materials in an exhibition telling the story of the 1974 Senate race in Vermont and related programming; Carly Dearborn (Ohio State University) described her copyright review work to digitize campaign bumper stickers; and John Caldwell (University of Delaware) talked about collecting political campaign documentation more broadly, including web archiving and building artificial political ephemera collections. After the lightning talks, we had a good discussion about the obscure campaign ephemera in our collections and how challenging it can be to get researchers to use campaign files. Join us for our next meet-up in the fall, hosted by the CPS Electronic Records Committee.

Nominations will be accepted through Wednesday, May 28.

We encourage anyone who's ever considered to run. Serving in section leadership is a good way to learn more about SAA's operations, gain valuable leadership experience, and build a resume/CV. The time-commitment is not exhausting, and the members of this section have a history of supporting one another.
