# American Archivist Editor (Prepared by Amy Cooper Cary)

### **DEIA**

- The Editorial Board will make the Peer Review process and rubric a main topic of conversation at the July Editorial Board meeting. We will continue our conversations about DEIA as it pertains to workflow, onboarding, and the peer review rubric. We will also work on a DEIA Statement for the landing page of *American Archivist*.
- Cary will work with the Publications program to set up a joint session (post-SAA Annual Meeting) for members who wish to be involved in the Peer Review process. This will allow us to discuss the peer review process across publications. The focus on DEIA at the Editorial Board meeting in July will allow us to bring this to potential peer reviewers.
- Process continues to explore options for Special Sections with chairs of the Committee on Ethics and Professional Conduct, and the Accessibility and Disability Section. Both groups have expressed interest. Cary is following up with interested parties.
- Cary will attend Helen Wong-Smith's upcoming SAA Education course, "Cultural Diversity Competency."

# **Publication Status**

- Vol. 83, no. 2 (Fall/Winter 2020) Published and included a statement about American Archivist
  pivot to digital, written in collaboration with the Editorial Board. The pivot statement was also
  shared broadly electronically. Thank you for the support Council has provided during this
  transition!
- Vol. 84, no. 1 (Spring/Summer 2021) Issue is nearing completion. Table of Contents is on next page. This includes the Presidential Address, as well as a reference to the 2020 Pease Award article.
  - We continue to explore options for early publishing. The Pease Award article gives us an opportunity to explore publishing outside of the traditional workflow. The author of the article is not ready to publish for 84:1 (as is traditional); Cary will shepherd her through the revision process to publish between 84:1 and 84:2.
- Vol. 84, no. 2 (Fall/Winter 2021) Special Section on Design Archives. We are slightly ahead of schedule with content for this issue. Content for both the Special Section and the "regular" articles have been through revision and will be sent to copyediting beginning in mid-May.
- Vol. 85, no. 1 (Spring/Summer 2022) Some content has been peer reviewed and accepted for publication. Cary continues to review content for inclusion in this issue.
- Backlog for review and decisions on all articles which were waiting for decisions (based on pandemic and editorial transition) will be completed by the end of May.

#### **Additional Items**

- As part of the SAA Awards Committee, Cary chaired the 2021 Theodore Calvin Pease Award selection committee for best student paper. The winning recipient has been selected and will be announced in May along with all other award recipients.
- CORDA follow-up meeting regarding collaboration between *American Archivist* and the SAA Dataverse is scheduled for May 10. This partnership considers the potential for adding datasets developed by authors during the research process to the SAA Dataverse.
- Editorial Board meeting scheduled for Friday July 23, 2021. Agenda items include:
