# Project Completed! Guides Published!

Concordia Historical Institute has completed a project to organize the papers of Dr. Walter A. Maier, first Lutheran Hour speaker, and Dr. Eugene R. Bertermann, an assistant to Maier, executive director of the International Lutheran Laymen's League and executive secretary of Lutheran Television. Guides to the collections have been published, and copies are available to persons interested in doing research on these two pioneers in Lutheran religious broadcasting.

The project was funded by a grant of \$27,500 from the National Historical Publications and Records Commission. It began in December 1991. Project archivist Jamie Lambing worked for a year to organize the papers, research related collections, prepare finding aids, and develop the manuscript for the printed guides to the collections.

Under this project the papers of Dr. Maier, received from the Maier family in 1980, have been arranged into an organized collection with a printed guide and inventory to help researchers use the material. Some 80 boxes of materials that had remained unprocessed for many years are now neatly arranged in 78 acid-free storage boxes in the Institute's archives stacks. The same work was done with files of Dr. Bertermann received in 1981 and 1983.

The guides to the collections include a biographical sketch of each man and a general description of the contents of the collections, how they were received by the Institute, and the steps taken in the processing of the materials. This is followed by a detailed listing of the contents of each file, descriptions of related collections at the Institute and in other locations, bibliographies of works by and about the two men, a glossary identifying the people and organizations with which Maier and Bertermann were involved during their careers and a detailed index of names and subjects.

Copies of the guides will be deposited in the libraries of all Missouri Synod colleges and seminaries and in other selected archival agencies. A limited number are available for purchase at a cost of \$10.00 for the Maier guide and \$7.50 for the Bertermann guide, plus \$2.00 for postage and handling.

Concordia Historical Institute is the Department of Archives and History of The Lutheran Church—Missouri Synod. Its facilities are located on the campus of Concordia Seminary in St. Louis and are open to the public from 8:30 a.m. to 4:30 p.m., Monday through Friday. Admission to the museum is free. Researchers who are not members of the Institute may consult its resources on payment of an access fee of \$10.00.

#### From the Chair...

Since I last communicated with you through this newsletter, I have had a very trying time. In the last few months I have lost my grandmother, my mother, and my aunt. I have gone through the transitions that are associated with death and individuals. I have also closed out two congregations which "died"-one in Detroit, Michigan, and another in Bedminster, New Jersey. Lest you misinterpret this column, I am not writing for sympathy, but rather to share with you my reflections on the archival profession which have resulted from these life experiences.

In our field, we often talk about the "life-cycle" of records—from "birth" to "death" or, more properly, from creation to disposition. We gather the documentation from various agencies, institutions, organizations, and individuals, often in a very dispassionate manner. Yet, the records which we preserve, reflect the "roots" of someone else. An individual's records will be all that ultimately is left to tell his or her life story. An organization will pass in time from the memory of society with nothing remaining except artifacts and records.

I have become more aware of the "stories" that are contained in the holdings which we preserve. I have also become more aware of the 'stories' we have as we travel through our profession-why we do what we do, how we entered into the field, where we hope to go, the successes and troubles we have experienced. # New Oral History Program

The Sisters of Providence, a Community of women religious founded in 1843 in Montreal, Canada, came to Vancouver, Washington Territory, in 1856. Led by Mother Joseph of the Sacred Heart, the Sisters established schools, hospitals, orphanages, and other social welfare institutions in the pioneer west. Today, the Sisters of Providence, Sacred Heart Province operate hospitals, manage care plans, schools, and low income housing in Alaska, Western Washington, Oregon, and California.

The history of the Community is rich. The Sisters of Providence Archives, Sacred Heart Province houses 2,500 linear feet of manuscripts, over 10,000 photographs, and myriad other media documenting the history of the Community and the Sisters' sponsored ministries. Recently, in response to a growing urgency to record the experiences of Sisters and others involved in the Providence mission, the Archives launched an Oral History program.

After a careful planning, the interviews are finally underway. Preparation was undertaken by a ten member Oral History Committee formed to define, plan, and launch the program. Committee members drafted lists of suitable narrators, interviewers, and topics to be covered and identified the most pressing interviews. In May 1993, the Committee attended a comprehensive Oral History Workshop in Vancouver, WA, conducted by Oral Historian Sharon Boswell, Ph.D., co-director of Partners in Time. The workshop covered interview techniques and the fundamentals of a program.

We seek to collaborate with members of the Archivists of Religious Collections Section engaged in similar oral history programs. We are currently in the process of developing accession and release forms. Please share your experiences and knowledge with us!

### NHPRC Grant Awarded to Harvard Divinity School

The Andover-Harvard Library at Harvard Divinity School has received a \$46,182 grant from the National Historical Publications and Records Commisssion (NHPRC) to process the records of the Unitarian Universalist Service Committee (UUSC).

The collection of the UUSC, established in 1939, is a rich resource for historical research on ethnic, religious and political refugees in Europe before and during World War II, especially refugees of the

Holocaust and veterans of the Spanish Civil War. It also documents the later work of the UUSC to promote development in Africa, Asia and Latin America, as well as in poor rural and urban communities in the United States.

The one-year grant will commence on October 1, 1994. The Project Archivist is Timothy Driscoll, who will work under the direction of Alan Seaburg, Curator of Manuscripts at the Andover-Harvard Library.

Harvard Divinity School obtained the UUSC records in 1975 from the library of the Universalist Historical Society at Tufts University. The NHPRC grant will make possible the preparation of a descriptive register of them, and the creation of a management program for the archival storage of current and inactive records.

The UUSC project is the outgrowth of another NHPRC-funded project at the Andover-Harvard Library to process the archives of the Unitarian Universalist Association.

In 1911 the library collections of Harvard Divinity School and Andover Theological Seminary were combined at Harvard to form the Andover-Harvard Theological Library. The 445,000-volume collection constitutes Harvard University's research collection for Protestant and biblical studies. Its particular strengths include biblical studies, early New England theology, the liberal movement in American theology, ministerial records from the Unitarian Universalist movement, and the Paul Tillich Archive.
