- In the short run how does our work interface with the A-Census Meredith Evans is
  interested in proceeding quickly with A-Census 2, fast-track; Council has approved our
  working with Ithaka for a grant application and has begun looking at previous instrument
  to gauge topics and what needs to be added; hopeful that we might find a funder by
  August or at the end of the year.
- Rather than get ahead of A-Census, position ourselves for a good meeting in Austin. Our committee has a 3-hour block and SAA has generously allocated a 75-minute open forum slot, inviting members to discuss with us their interests in data and research broadly
- One thing that we decided was CORDA charge is anything and everything we might
  want to do. We acknowledge right from the start that there is no immediate hope of
  getting a dedicated staff member to support the work of the charge, and ramping up the
  committee
- We understood long before we submitted the report that the group would start out slowly, with a few priorities, and started to build information and a repository, and gradually expand to include all of those 7 things in the charge.

## Tasks from the Task Force Report:

- 1. Standardized Tools for gathering and analyzing data
- 2. Centralized repository (of data tools and other authoritative aids- it will be the other teams that assemble the content that will go into this repository)
- 3. Training on gathering, analyzing, interpreting and using data
- 4. Up-to-date basic facts and figures about archives and archivists
- 5. Clearing-house to support surveys and research

## Tasks in the CORDA Charge:

- 1. Looking strategically at the organization's information needs and sharing its strategies with the SAA Council and relevant component groups;
- 2. Proactively commissioning or directly engaging in necessary and strategic research;
- 3. Gathering quantitative and qualitative information of strategic value for SAA in the areas of advocacy, public awareness, improved audience service, and community engagement;

- 4. Evaluating such information and surfacing it to SAA members via dashboards, reports, and constructed data sets that members can use to better understand and act on their own environments and to perform better as archivists;
- 5. Engaging academic and other communities within SAA to perform research by helping to set research agendas and by utilizing grants, fellowships, conferences, and other tools and levers;
- 6. Providing a repository (or repositories) and analytical tools for sharing and evaluating useful data about archivists, repositories, audiences, and the environments in which archives function; and
