1. Assessment and Evaluation:

- Prepare and circulate for open peer review a white paper that defines research, evaluation, and assessment in the context of the archival profession, archival work, and roles and responsibilities of archivists.
- Further analyze and gather data from earlier survey, upload materials into SAA
 Dataverse
- Connection to research agenda: gathering additional datasets from suggestions
- 1. Education and Training: (add Outreach?)
 - Publish regular updates in "In the Loop" on CORDA activities.
 - Additional workshops, training? Offer data workshop again?

1. Repository:

- Negotiate a Memorandum of Understanding between SAA and UNC Chapel Hill

- Seek funding for resources needed to prepare research datasets for upload into the SAA Dataverse.
- Working with new Editor of The American Archivist, explore the feasibility of utilizing the SAA Dataverse as a repository for data related to published articles.
- Establish policies for SAA Dataverse, including collection scope, technical requirements, access procedures, and copyright and privacy limitations.
