

IMPACT OF NHPRC IN FLORIDA

The National Historical Publications and Records Commission (NHPRC) promotes the preservation and use of America's documentary heritage essential to understanding our democracy, history, and culture. Since 1964, the NHPRC has awarded \$207 million to 4,900 projects in all 50 states and special jurisdictions.

Total Cost of Projects supported by NHPRC in Florida:

- **\$4,260,851 – Total Project Funds**
- **\$2,140,420 - Direct Federal Grants**
- **\$2,120,431 - State and Local Contributions**

Projects of Special Value to the State of Florida:

The NHPRC has played a unique role in supporting historical RECORDS projects of special value to Florida including...

- **Establish Network of Archives in Florida** – support to establish or enhance archives programs at the University of Florida, Ringling Museum of Art, City of Miami, City of Tampa, and many other repositories.
- **Disaster Preparedness and Recovery Training** – grants to support statewide efforts to protect and recover records in the event that disaster strikes.
- **African American Heritage and Communities** - funding to preserve archives and historical records of Florida's African American history and culture including grants to Florida A&M University, Florida State University, and the John Gilmore Riley/Museum of African American History and Culture among others.
- **Public Records Support** – funding to preserve and make available essential public records from Florida's local governments including births, deaths, marriages, property ownership, etc.
- **Heritage support for Local Florida communities** – support for preserving historical records held at dozens of smaller Florida repositories.
- **State Archives Support** – support to help enhance the state archives program by updating holdings and providing administrative support in Florida including a program that has redistributed funds to local institutions.
