4. Repository Research

a. Discuss strengths and weaknesses of Dataverse Project as model for SAA Data Repository. https://dataverse.org/

- b. CORDA discussed questions raised by Dataverse Implementations at Toronto (Scholars Portal), Harvard, UT Austin, and UNC Chapel Hill.
- c. The major advantages of Dataverse are: open source, open APIs, great technical documentation, international implementation at scale across 46 instances, and flexibility in terms of resources deposited and access options over time.
- d. Some of the challenges of implementation include locating a host site, estimating storage needs and costs over time, technical management, understanding analytics, and the wide range of policies and procedures that must be developed.
- e. The Committee decided to continue the conversation about implementation challenges and opportunities in Austin.
- 5. Scope of Repository and CORDA support for research activities
 - a. CORDA members brainstormed on the scope fo the data and associated documents that might be assembled in a repository, recognizing a range of options from comprehensive to selective.
 - b. CORDA members began a discussion on the expectations that CORDA will foster new research, evaluation, and assessment. Discussion tabled until Austin.
