Our panelists bring a wealth of knowledge and experience to this conversation, and will bring insight from their backgrounds at a large public university, a small private university, and a museum archives. Of course, we know that this section has more to offer than just events and discussions at the annual meeting, so the steering committee is excited to announce the other project they have been working on this year! Partnering with SAA's Career Development Committee, we will be launching a pilot resume review program exclusively for members of the Manuscript Repository Section (MRS). The recent

expansion of the Career Center's work during the annual meeting has been incredibly successful and offers an important service to members. However, we are fully aware that it is not always feasible to devote the time and financial resources to attend the annual meeting each year. In light of this, the MRS steering committee wanted to offer a way to provide similar career development opportunities to all section members on a year-round basis. This initiative will allow section members to submit resumes and receive feedback from peers in order to hone their job hunting skills. It will run this summer from June to August, with the goal of having feedback returned to all participants prior to the annual meeting. We will be sending out a call shortly to identify interested participants, as well as volunteers to review resumes. Since this is a pilot, we will need to keep the number of participants small. However, the results and feedback generated by the pilot will be examined to determine whether this is a sustainable initiative that can be implemented in a more formal way moving forward.

In closing, I encourage everyone to keep your eyes out for the link to the officer and steering committee ballot that will be headed your way in an email the week of June 25th! Ballots will close the week of July 16th, which should give everyone time to vote regardless of your awesome vacation plans!

GEORGIA HISTORICAL SOCIETY ANNOUNCES THE COLLIER FAMILY PAPERS OPEN FOR RESEARCH


The Georgia Historical Society (GHS) is pleased to announce that the Collier Family Papers (MS 2665) are now available to researchers at the GHS Research Center in Savannah. The collection contains the papers, records, photographs, and correspondence of the Collier family of Barnesville, Georgia, particularly Jena Cuthbert "J.C." Collier (1866-1944) and his son Durward Cuthbert "D. C." Collier (1890-

1979). The collection was donated to GHS by Glen A. Collier, on behalf of the estate of Virginia Collier Dennis, the late daughter of D.C. Collier.

The Collier family was active in agricultural, textile manufacturing, and politics of the Piedmont area of Georgia during the late nineteenth and early twentieth centuries. J.C. Collier was born in Pike County, Georgia, to Isaac C. and Sarah E. Collier. In 1881 he left his father's Piedmont, GA plantation to attend the Gordon Military Institute in Barnesville. After graduation he began work at C.C. Holmes Dry Goods, eventually opening his own store, J.C. Collier & amp; Co. J.C. Collier would go on to serve as Mayor of Barnesville and as a Georgia State Senator for the 2 nd district from 1925-1927. He remained an active figure in Georgia politics.

D.C. Collier graduated from Georgia Tech with a degree in textile engineering and joined his father's manufacturing business. In the 1940s he worked for the United States Quartermaster. Like his father he was also active in politics though he never held public office.

Materials within the Collier collection cover the period from approximately 1910 through the 1930s and contain both personal and business correspondence, including J.C. Collier's opinions on the New Deal and discussions with prominent political figures of the time. There are also records of a lawsuit against the United States government over the cancellation of a World War I government contract that took decades to resolve.



My name is J. C. Collier, President of the Collier Manufacturing Company of Barnesville, Lemar county, Georgia, and under oath wish to state that I was President of the Collier Manufacturing Company in 1917, also 1918. I was the chief executive officer handling the up town office. Along in the spring of 1918 we received communications from the Depot Quartermaster's office of St. Louis asking for quotations for immediate delivery, also future delivery, on undershirts for the army. A little later we also received communications from the Depot Quartermaster's office at Atlanta. We knew that the war was coming on and I went up and talked with the officials personally, soliciting their business, as at that time we were all willing and anxious to help all we could in the World War. We knew that the United States of America was fixing to join the allies. I received a sample from the Depot Quartermaster's in Atlanta of the exact type of undershert wanted, I returned to Barnesville and took the matter up with my sen. Mr. D.C.Collier, who was Vice-President and General Superintendent of the mill. We decided we could make the shirts very successfully and immediately got our samples and submitted them to the Atlanta Quartermaster's office; the samples we submitted pleased the Atlanta Depot Quartermaster's office, we then sent on to our New York agents samples to be submitted to the Civilian Buying committee at their office on 16th Street, New York City. The army officials in Atlanta wished quick deliveries and suggested that we have Messrs Clift & Goodrich, the regular selling agents of the Collier Manufacturing Company to take the order and forward same on to the mill, as Clift & Goodrich had already

The collection consists of 125 boxes, two rolls including an architectural drawing of a dry goods store, and 87 volumes including journals, ledgers, and daybooks. Materials will be of particular interest to researchers interested in the Great Depression, the textile industry, Georgia land management, and the politics of the 1920s and 1930s.

KEY RECENT ACQUISITIONS AT WEST FLORIDA HISTORY CENTER

Among our acquisitions and gifts recently are three different collections.

Photographs, 1920s

Six Eastman Kodak books capable of storing 100 4x5 negatives (most full), covering scenes in and around Pensacola and Escambia County, 1920s. Each storage booklet has a descriptive page in the front identifying each photograph. We imagine that the creator might be an individual or company who repaired roads, bridges, or worked on them. Includes family photos as well. Other topical paths include the history of roads and history of bridges.





Albert E. Wiemann Papers

Wiemann was an engineer who lived in Pensacola. Family photograph scrapbooks covering 1919-1923, identified; includes Long Island, Boston, trips to Atlantic City; City College of New York, etc. With

additional photographs 1899-1910 including the Dewey Memorial Arch, return of Navy from World War I, etc. Also a genealogical album covering German family from 1865 through 1900s.

BP Oil Spill Archives

On May 17, 2018, the Escambia County Board of Commissioners voted to donate all of their records concerning the Deep Horizon Oil Spill to the UWF Archives and West Florida History Center. This single most devastating environmental disaster to hit the region created reports, studies, e-mails, and other materials as the region coped with and struggled to overcome the accidental oil damage to beaches, wildlife, and tourism. We have not physically received these materials yet, but they add to our growing collections of environmental students in the region including recovery at two superfund sites, studies in off-shore drilling rights, and the Destin Dome project (another oil exploration and drilling).

THE UNIVERSITY OF WISCONSIN-MADISON ANNOUNCES THAT THE NELLIE Y. MCKAY PAPERS ARE OPEN FOR RESEARCH


The University of Wisconsin-Madison University Archives is pleased to announce that the Nellie Y. McKay papers have been processed and are open for research. McKay joined the faculty at UW-Madison in 1978 and helped establish an African-American literature curriculum in the department of Afro-American studies. Her work focused on black women's literature and multicultural women's writings and she published more than 60 essays, and book and journal articles on such writers as Harriet Jacobs, Ida B. Wells, Zora Neale Hurston, Alice Walker, and many others. In 1996, she co-edited the *Norton Anthology of African-American Literature* with Dr. Henry Louis Gates, Jr. which was one of the first works to canonize black American literature.

Nellie McKay's papers span 13.3 cubic feet and include personal and professional correspondence, manuscripts and writings, research files, and course materials. Notably, the collection includes the editor's manual of the *Norton Anthology of African-American Literature* which includes notes from Gates, McKay, and other editors and details the criteria for inclusion in the anthology. The finding aid for the collection will be available in Fall 2018, once the University Archives adopt ArchivesSpace. The Henry W. Pilch Collection is now open for research at the Morristown & Morris Township Library's North Jersey History and Genealogy Center

Jeffrey V. Moy, Archivist Morristown & Morris Township Library North Jersey History & Genealogy Center The Henry W. Pilch Collection provides an account of land usage in New Jersey from the 18th through the 20th centuries. A practicing attorney for four decades, Henry W. Pilch (1902-1987) collected the bulk of these records while performing title searches for real estate transactions. In addition to tracing property ownership throughout Morris County and Northern New Jersey, the papers follow the family histories of numerous prominent and longtime residents.

Henry's lifelong interest in history and genealogy led him to spend countless hours conducting research in the Morristown and Morris Township Library's local history department, to which he donated his notes and legal papers in 1987; they consist of 125 linear feet of family and municipal histories, maps, deeds, mortgages, and surveys. The papers illustrate centuries of residential

expansion, agricultural development, as well as the acquisition of land for public infrastructure needs. The records are particularly valuable to genealogists, homeowners and businesses owners, and scholars of state and local history.

Arrangement and description of the records began in 2014 and was completed in May 2018. Related collections include hundreds of historic and hand-reproduced maps, also donated by Mr. Pilch, along with a group of land records acquired from the Minton and Day law firm.
