A critical step in pursuing the research portion of its mission is the recently developed and actively evolving *Research and Innovation Roadmap*, which asserts the critical research needs and gaps that have been identified to date by members across the profession. The roadmap reflects an analysis of current and emerging research, assessment, and data needs, to frame and inform research endeavors the profession might undertake in the years to come.

A crucial step in further developing the Roadmap is to present it to important SAA constituencies so that they can help us refine it into a more accurate and comprehensive expression of the profession's most important research needs. We need your help in identifying what's missing in the current document, what's unnecessary, and what needs more refinement.

 Seeking Feedback to develop Research and Innovation Roadmap before presenting to Council, goal is to present in May

- Question 1: What is missing?
 - Research into collections on cognitive technologies, like AI, robotics, etc.
 - Is there significant overlap between Audience Building and Metrics and Institutions?
- Question 2: What is here that shouldn't be?
 - Folks who don't work at a university might not have the same incentives or support to perform research.
 - Resource gap in organizations/institutions.
 - What will the end product look like? A wiki? Press products?
 - Would it include things on archives that are not necessarily written by archivists (discussing software, for example)?
