Summary of meeting activities and highlights: During the business portion of our annual meeting we updated our members on the activities and accomplishments of the Preservation Section Steering Committee and its subcommittees over the course of the 2024-2025 year. The programming portion of the meeting featured a panel discussion on "Preservation Outreach Strategies: Communicating the Urgency and Value of Preserving Cultural Heritage." The panelists explained how archivists can be effective in communicating the value of preservation to diverse audiences, including institutional stakeholders as well as the general public. The discussion also included ideas on how to educate the public on the risks to cultural heritage and how those risks may be mitigated and losses prevented through timely investments in preservation programs and services.
