II. OUTREACH

A. Archives Short Fiction Contest a Success!

Back by popular demand, the third installment of the <u>Archives Short Fiction Contest</u>, sponsored by the Publications Board, closed October 31. There were 30 stories submitted featuring an archives, an archivist, or archival materials. Jeanne Kramer-Smyth's <u>"Quarantine"</u> won first prize (publication in Jan/Feb 2019 *Archival Outlook* and on the SAA website in December as well as \$250). There were

three honorable mentions: Rebekah McFarland for <u>"Ester Jones Diaz"</u>, Nancy Freeman for <u>"Risk Versus Benefit"</u>, and Michelle Sayers for <u>"דשבו א דושאעקק יצחק"</u> (Yitzchak Jaeck, An Account)" (all published on the SAA website in December). This year's contest was judged by three past contest winners. The two previous contests yielded 33 and 34 submissions.

These numbers give an indication of the use of *American Archivist* DOIs and the traffic coming to americanarchivist.org site from users clicking DOIs. The DOI links are largely from links in other publishers' journal references to your articles, but they are also from DOI links in secondary databases, links from libraries using DOIs, and even DOIs in used in print versions. When a researcher clicks on a DOI link for an article, that counts as one DOI resolution. A DOI resolution is when a DOI is "clicked."
