Position: Vice Chair/Chair-Elect

1. Nominee: Sarah Cunningham

Bio/Statement: Sarah Cunningham is the Audiovisual Archivist for the Lyndon B. Johnson Presidential Library and is responsible for media digitization projects, processing collections, the preservation and transfer of vintage audiotapes and the storage of information and digital delivery. (2003 – Present)

In addition to her duties at the LBJ Library she created a curriculum for and teaches two courses in Audio Preservation and Reformatting (2005 – present) at the Graduate School of Information at the University of Texas at Austin. She served on the executive board of the Association for Recorded Sound Collections and is on the steering committee for the Society of American Archivists Recorded Sound Round Table. She is a frequent speaker and panelist in the recorded sound field.

Position: Web liaison

1. Nominee: Jolene Beiser

Bio/Statement: Jolene Beiser has been working as an Archivist at the Pacifica Radio Archives since November 2010. Her primary responsibility is as the Project Archivist on Pacifica's two-year NHPRC-funded grant project American Women Making History and Culture: 1963-1982. For this project she is coordinating the digitization of nearly 1,700 reel-to-reel tapes, and updating legacy catalog records through two levels of cataloging–editing item-level descriptions with standardized metadata, and creating a searchable online finding aid available at the Online Archive of California. In 2012-2013 she led the development of a new Drupal-based content management system for the Pacifica Radio Archives, updating legacy records to up-to-date metadata standards, and allowing for easy sharing of content with web users.

She is currently serving as Chair of the SAA Recorded Sound Roundtable until August 2014. She has presented her work at SAA's 2009 and 2013 Annual Meetings, and the 2013 ARSC Conference.

Position: Steering Committee member—Vote for up to 4

1. Nominee: Eric Cartier

Bio/Statement: I'm the Digital Librarian in charge of Digitization Center operations at the University of Maryland Libraries, and I'm interested to serve as a Steering Committee member.

We've had a functional audio digitization setup here since early 2013, and myself, a colleague, and graduate student assistants have refined it in many ways since then. Everyday we're transferring recordings on obsolete formats from WMUC (our college radio station), broadcasting collections, and literary manuscripts collections, and making them accessible directly to researchers or via ingest to our Digital Collections. Our documentation and setup are such that we are building a satellite center called the Performing Arts Audio Digitization Studio (PAADS) to ramp up digitization of valuable content on degrading carriers, a task of urgent importance these next couple of decades. I live and breathe this work, so I think I can make a valuable contribution to the Recorded Sound Roundtable by serving as a Steering Committee member, and would likely like to do so for more than one year. 2. Nominee: Shannon Erb

Bio/Statement: My name is Shannon Erb, and I am interested in running for a position on the steering committee. I am a student (finishing my MLIS this August) at the University of Wisconsin – Milwaukee, and the Moving Image Digitization Specialist at the County Music Hall of Fame. I am also an active member of ARSC, AMIA, MAC and SAA.

However new to the field, I have pioneered many recorded sound projects at my former employers, as well as hold a weekly radio show that focuses on archival tracks.

In graduate school at UW-Milwaukee, I served a duel position as the President and Treasurer of their SAA Student Chapter, as well as am an active board member and chair for many local organizations.
