Review of past year's work:

- William Maher presented at the International Copyright Institute sponsored by the US Copyright Office on Sept. 30, 2022 "Archives and Copyright: The View from SAA"
- Jean Dryden and the ICA issued a statement about copyright and archivists: [www.ica.org/en/ica-copyright-declaration](http://www.ica.org/en/ica-copyright-declaration)
- Aprille McKay and Council Rep. Krystal Appiah met with new Executive Director Jacqueline Price Osafo and Felicia Owens to introduce IPWG and discuss staff support and leadership involvement in recruiting new members in December 2022
- Cathy Henderson created a last minute session proposal, which was accepted by the program committee
- William Maher coordinated the process for SAA to sign on to a WIPO Broadcast Treaty Opposition Letter, propounded by Public Knowledge: <https://publicknowledge.org/policy/wipo-broadcast-treaty-opposition-letter/> in December 2022
- We considered whether to sign on to Public Knowledge's amicus brief related to Carl Malamud's effort to increase public access to law, and in part because of quick turnaround required and in part because it was an edge case for archivist advocacy we declined
