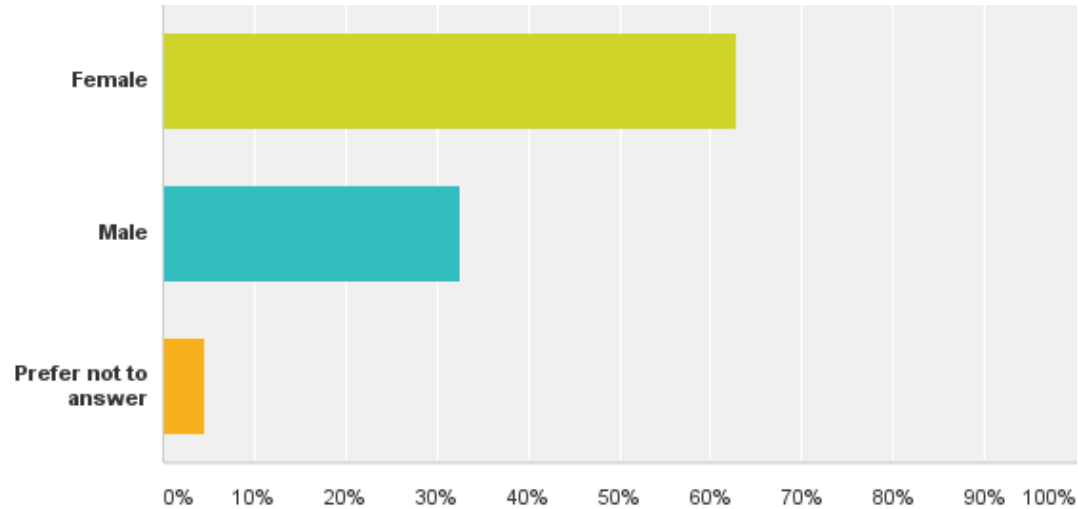

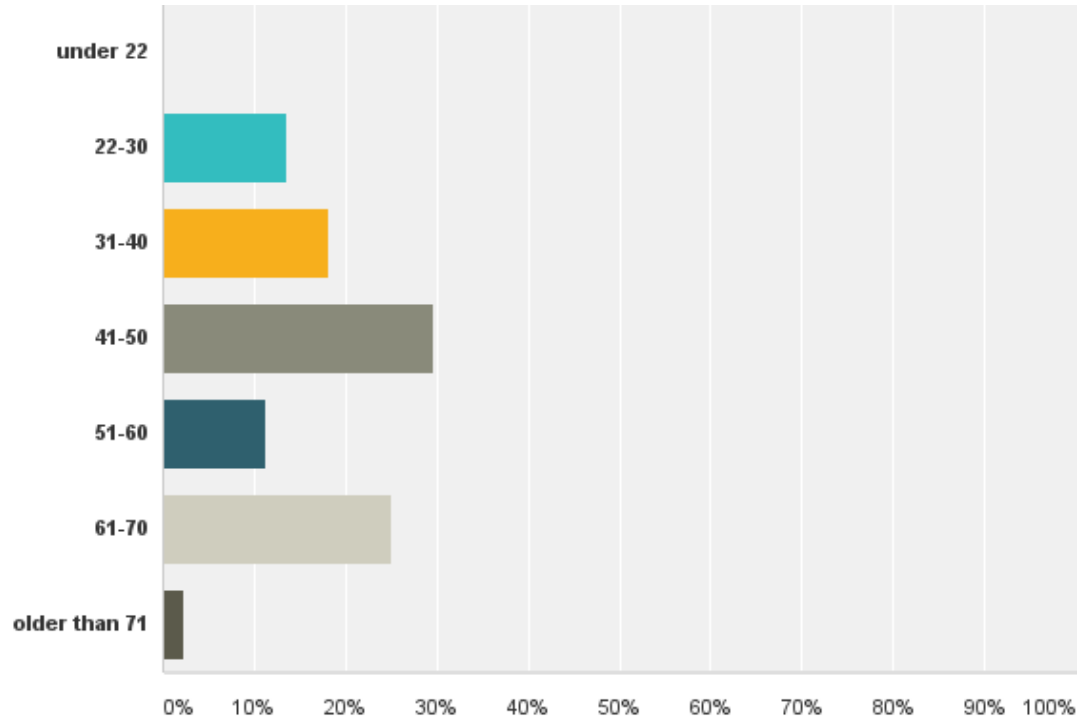
Q1: What is your gender?

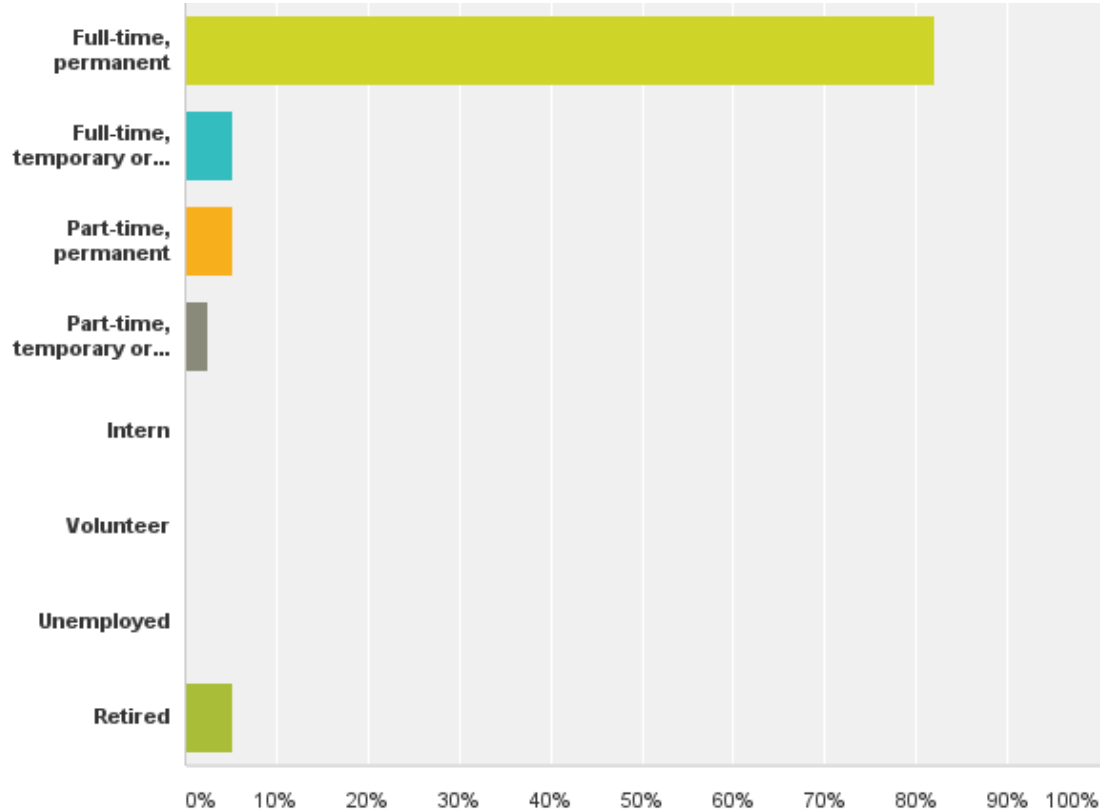
Q3: In what part of the country do you live?

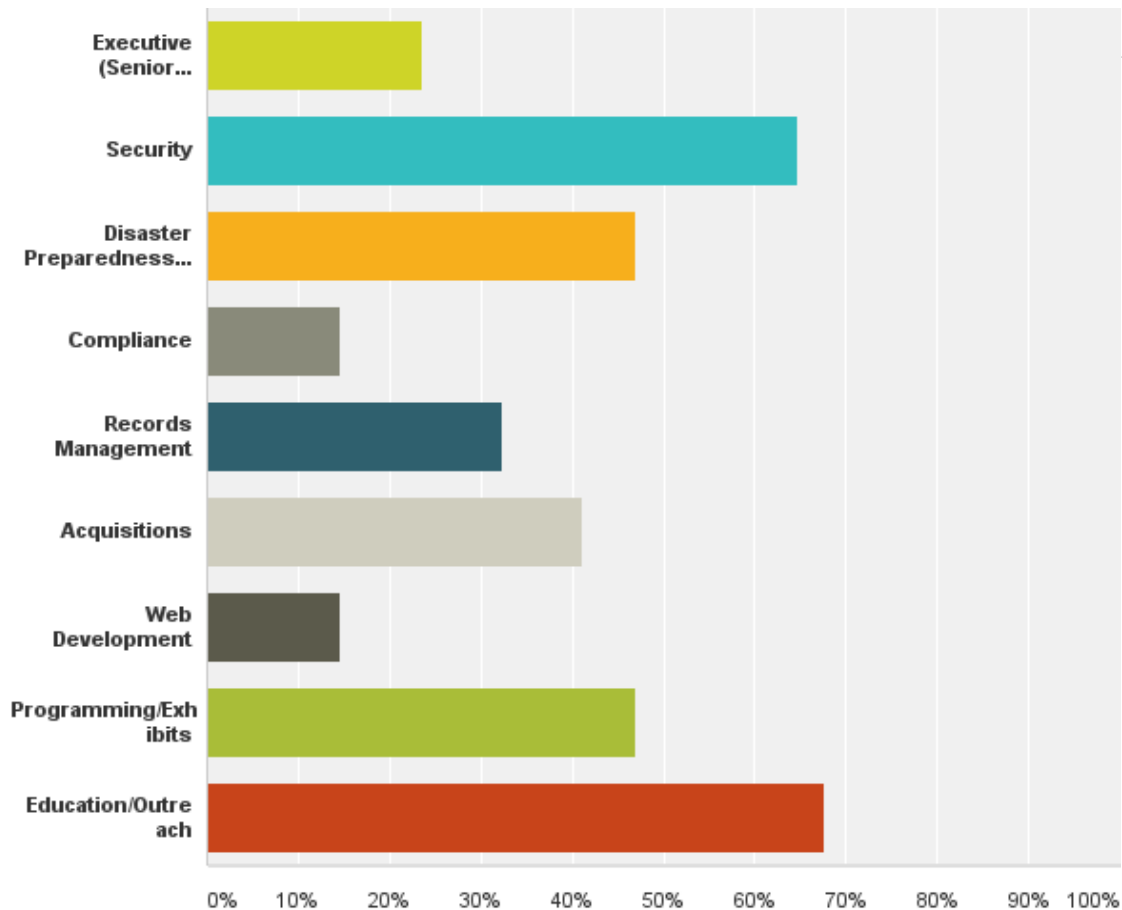

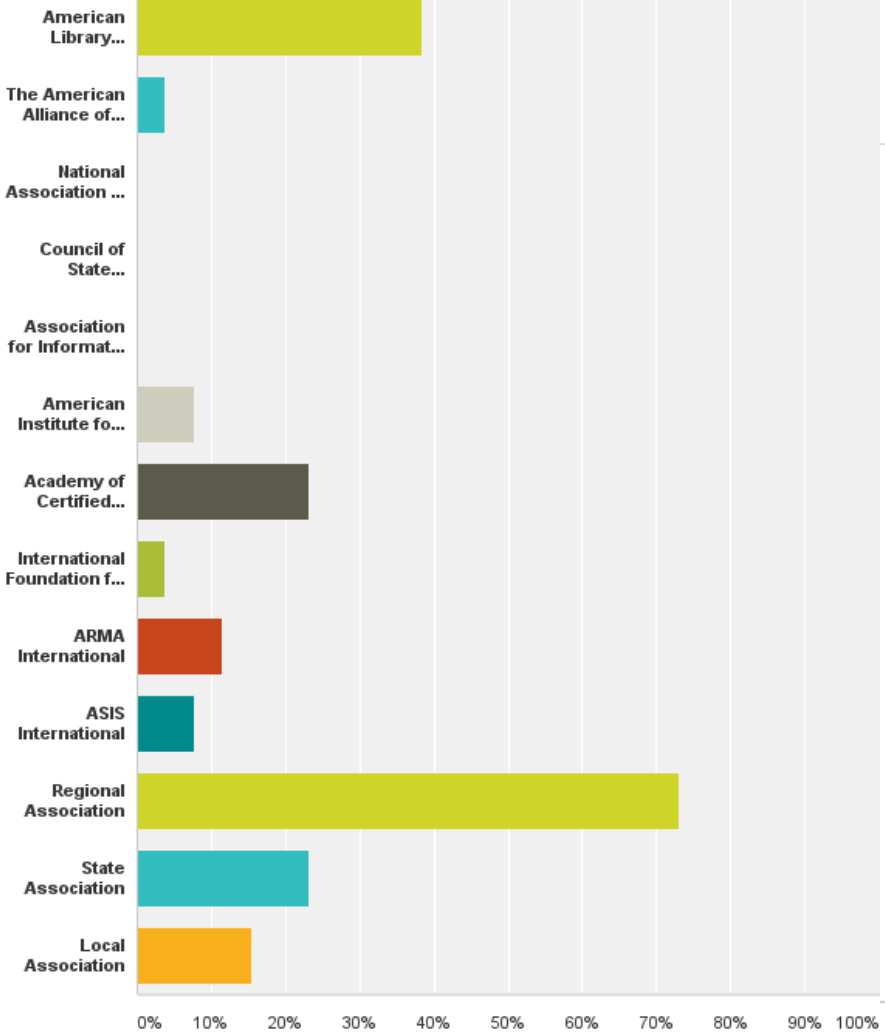

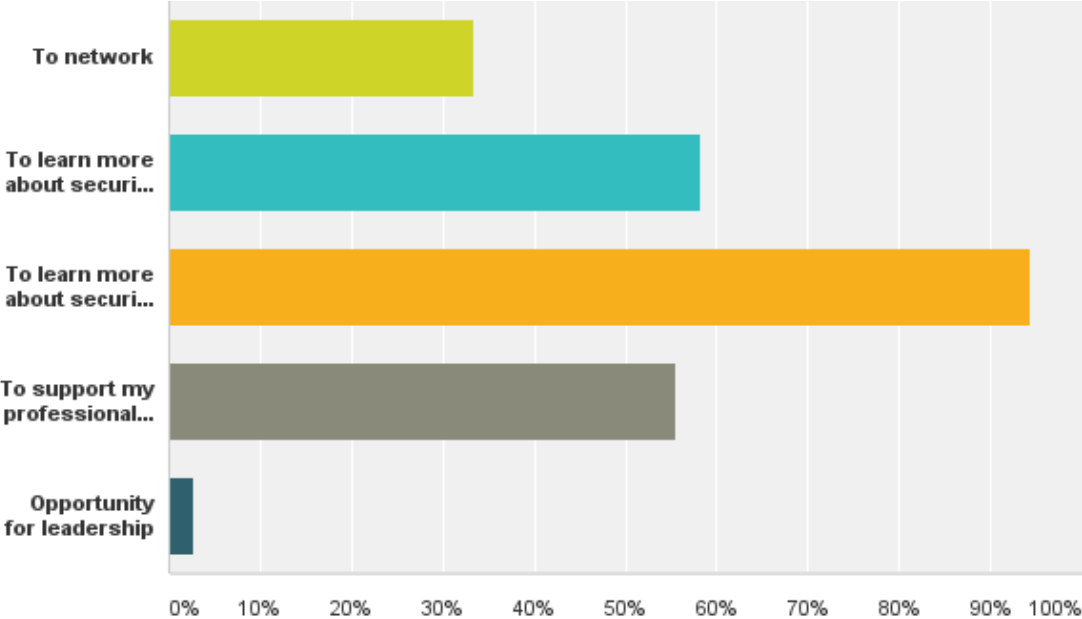
Q12: Which external groups do you also belong to?

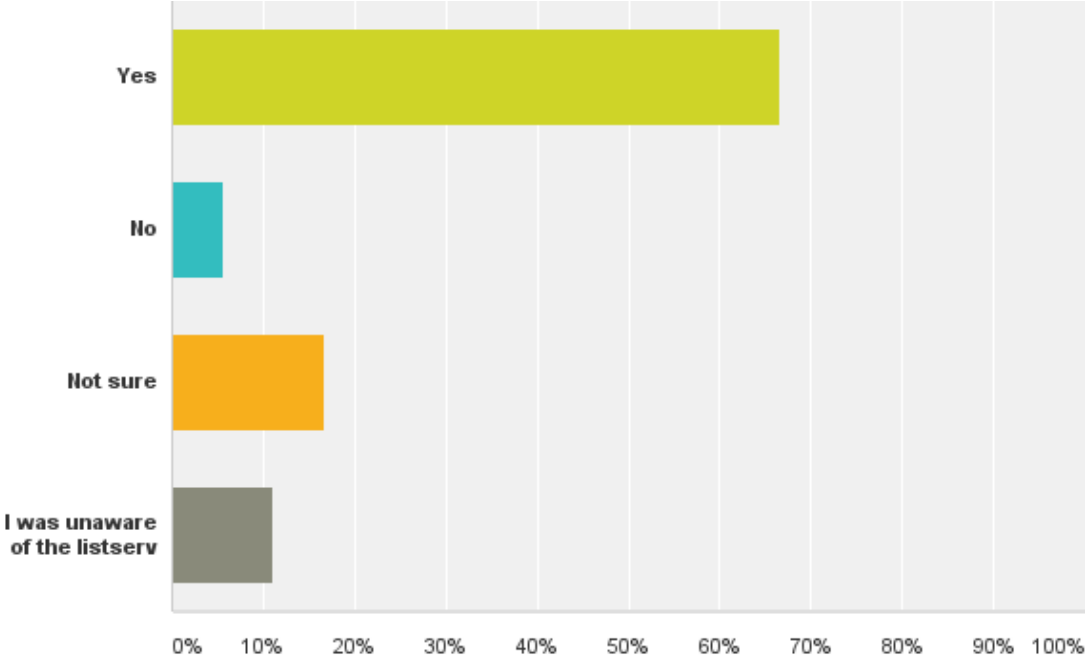
Q13: Why did you join the Security Roundtable? Choose all that apply.

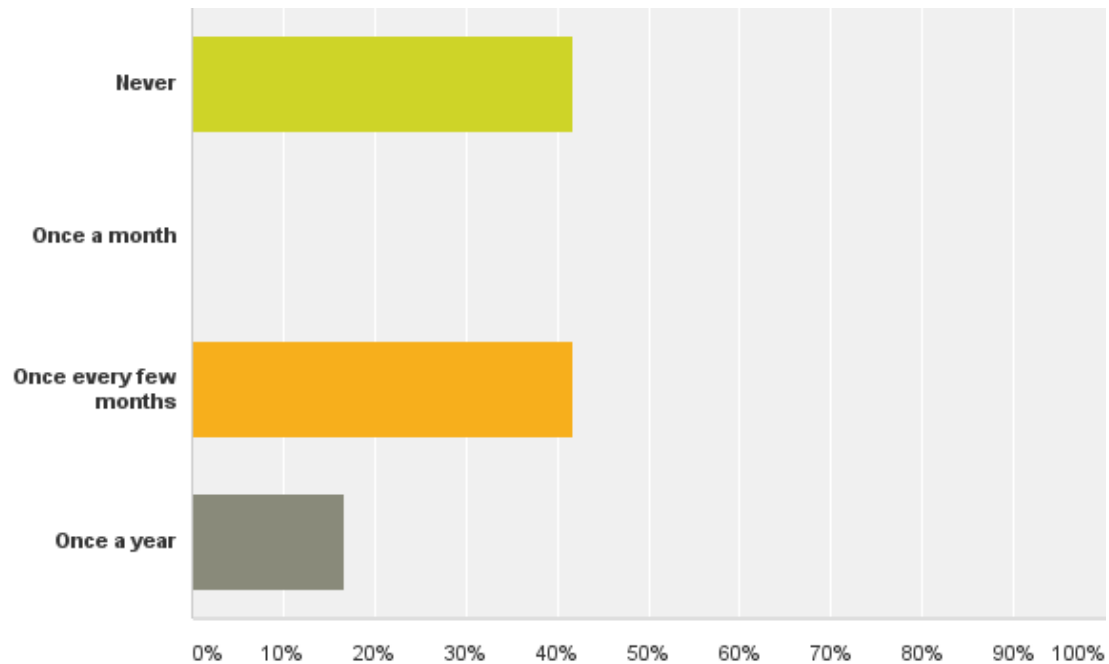
Q14: Are you subscribed to the Security Roundtable listserv?

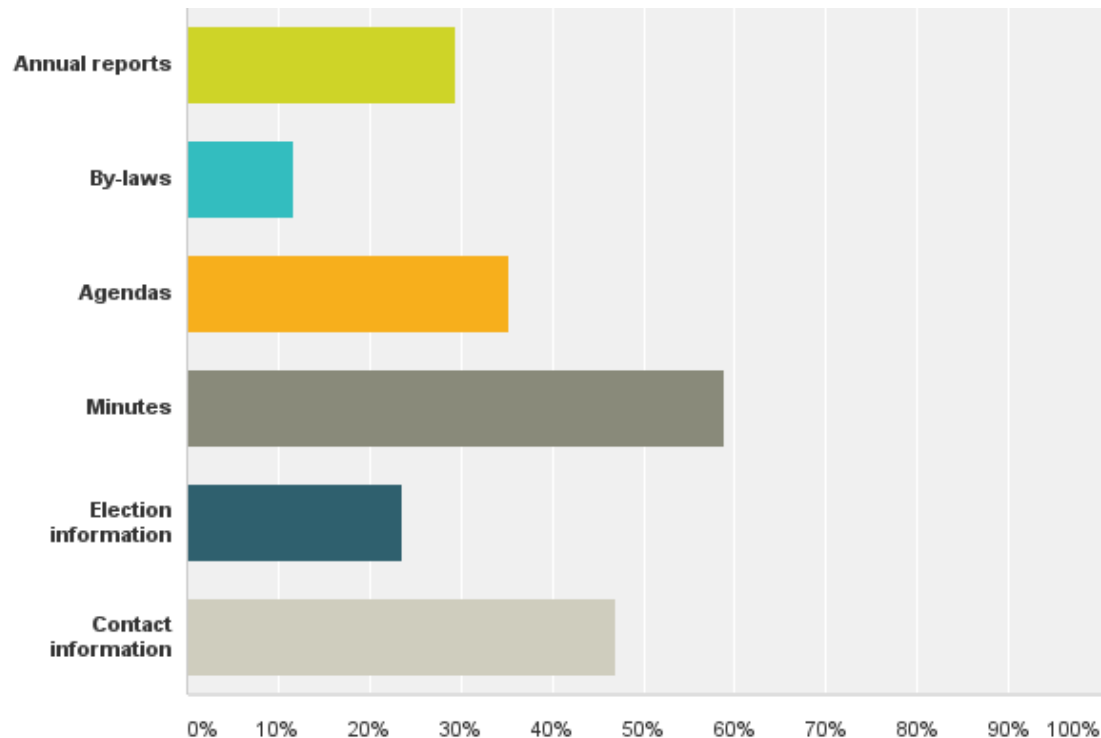

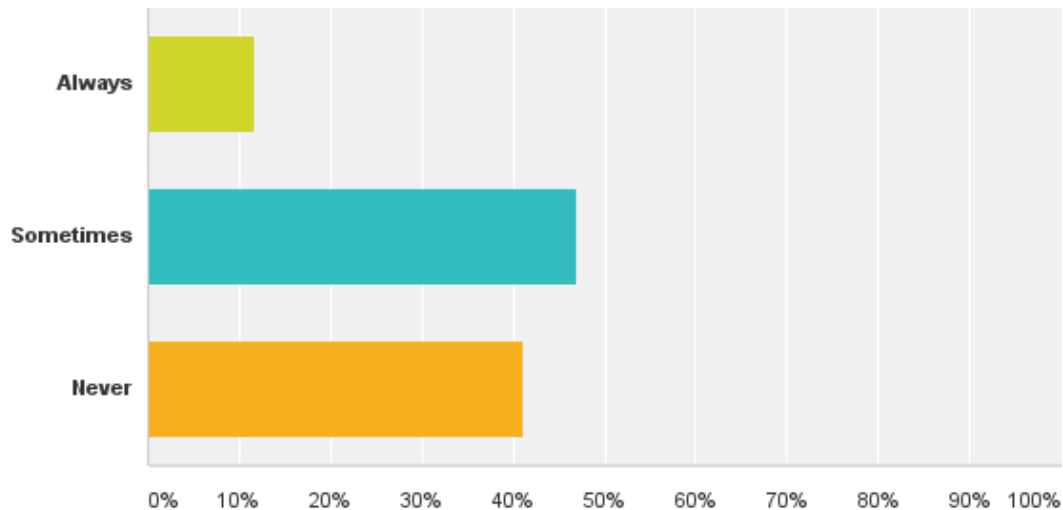
Q17: What else might you like to see on the Roundtable microsite? Choose all that apply.

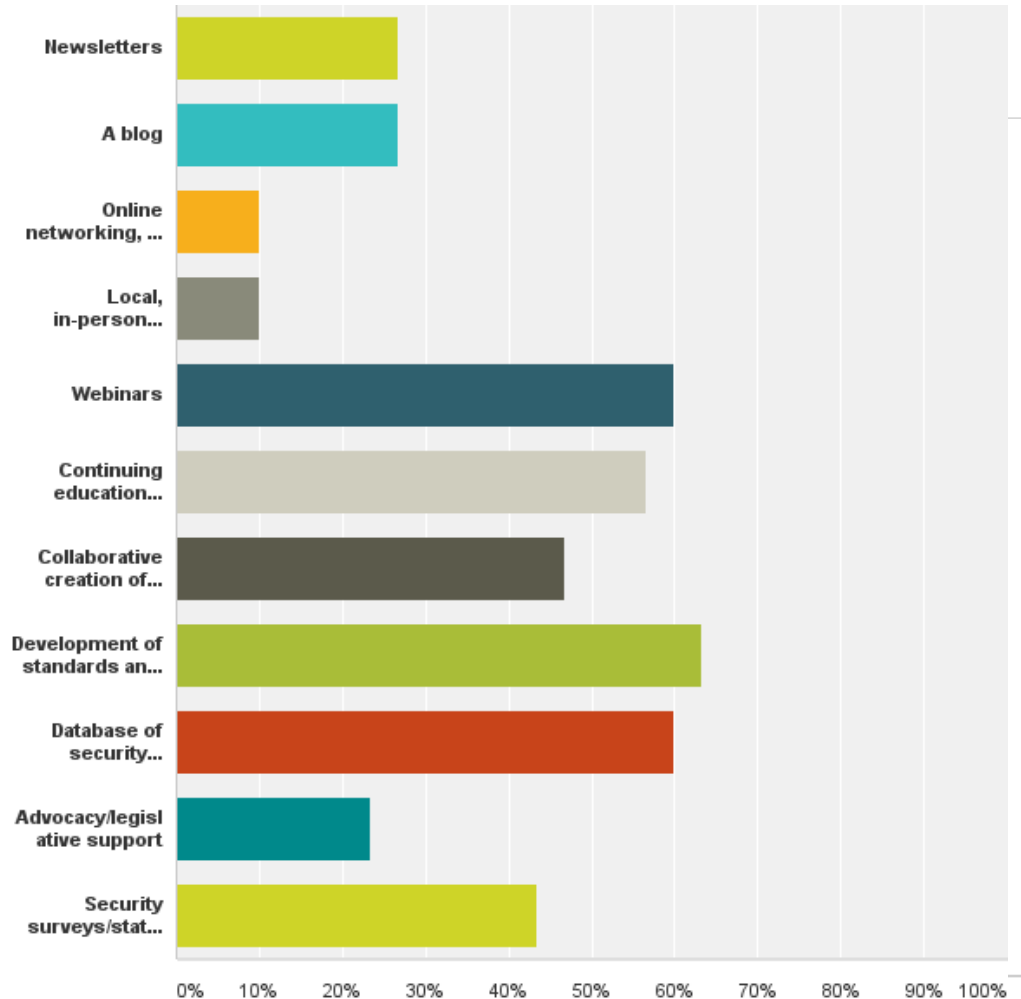
Q20: What do you most value about the Security Roundtable?

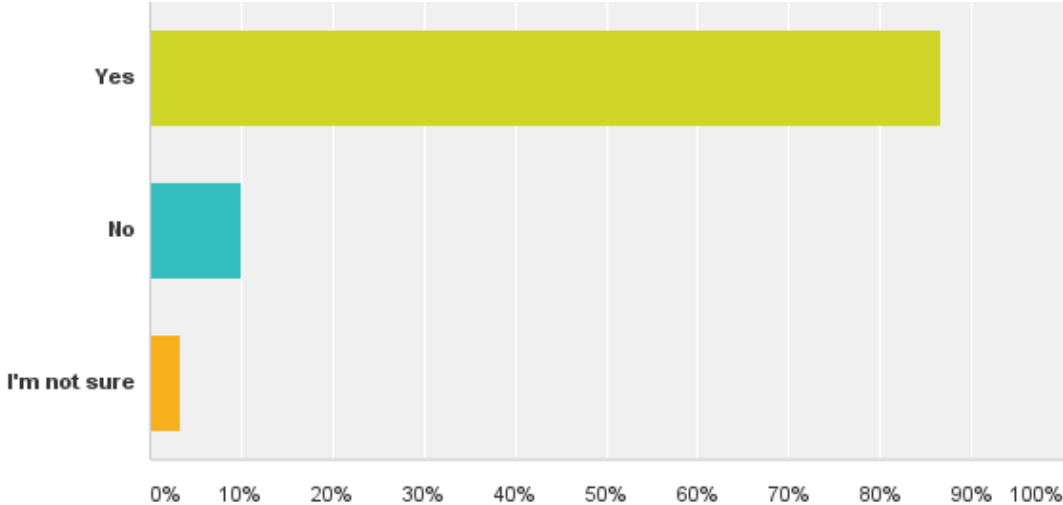

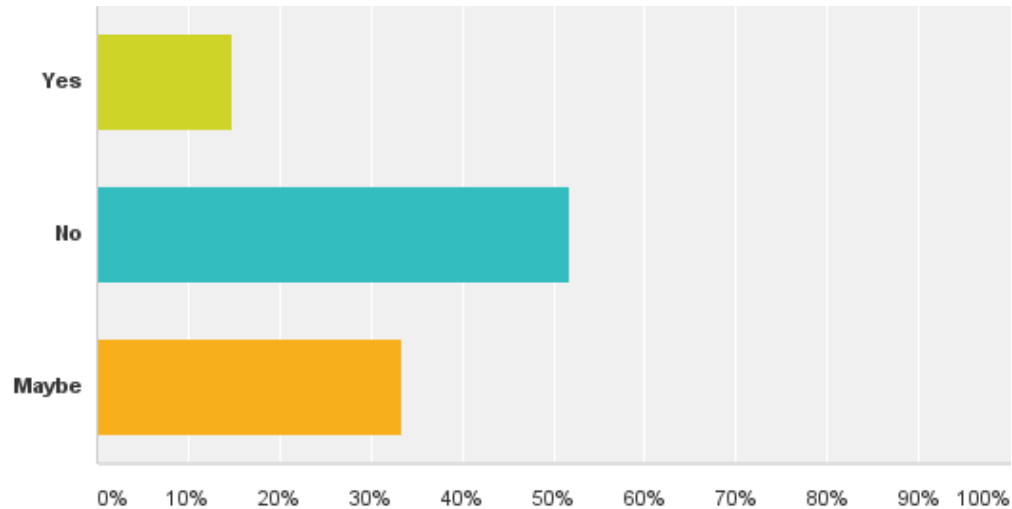

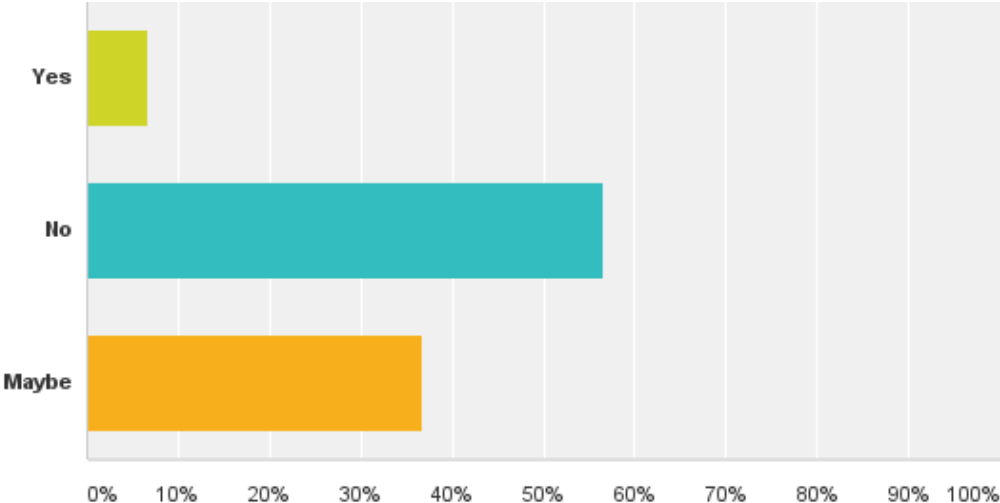
Q25: Would you be interested in participating in SAA's mentoring program (<http://www2.archivists.org/membership/mentoring>) and mentoring someone interested in security?
