**Work Plan**

- Woody would like to do a retrospective on American Archives Month as a blogpost. Another post on a list of resources/toolkits on discussing the value of archives. There are many resources on the SAA website related to AAM and also an early partner in CoSA.

- How can we reach out to NCPH and go beyond “archivists talking to other archivists.” Is it too late for this year since the day is two weeks away? Barbera would be willing to reach out next year.
- Need to go out with the date soon after this year’s event. Although it has been traditionally held the first Wednesday of October, be specific about what that date is.
- What about moving it to toward the end of the month and using American Archives Month to build up to the event. What about moving it from the first toward the fourth Wednesday of October for 2020? Let revisit after this year’s event.

**ARCHIVES/RECORDS 2019 Recap**

- COPA meeting on August 3 was productive (see [minutes](#) from the meeting).
- COPA session, “Are you ArchivesAWARE? Teaming up with SAA’s Committee on Public Awareness to Create a Stronger Archives Community,” on August 4 had 31 attendees. Good blog ideas and contacts for authoring posts were made.
- The two-hour storytelling workshop facilitated by Micaela Blei on August 2 was awesome. It was at capacity with 60 attendees. Would be good to discuss possibly expanding the workshop for the 2020 annual meeting.

**TO DO #9: Brinati to share feedback on the Storytelling Workshop.**

- “A Finding Aid to My Soul” storytelling event on August 4 has 10 storytellers and more than 100 folks in the audience. A polished and entertaining production thanks to Micaela Blei who did a great job as emcee of the event. New this year: rather than judges, Blei had three teams of audience volunteers who suggested titles for each of the stories and each storyteller picked out the one they liked best. Change for next year: Consider round table set up than theatre style.

**TO DO #10: Burns to pursue converting the audio recording of the event into episodes for the podcast Archives in Context.**

3. Burns and Trammell recorded 20 elevator speeches for the podcast Archives in Context; next steps is edit them into a podcast episode. Same goes for the StoryCorps content, which Burns is continuing to work on.
