Reappraising Our Professional Identity: Addressing the Knowledge Gap with Tenure and Promotion for Academic Archivists

Abstract: According to the 2017 WArS-SAA Salary Survey, approximately 39% of archivists and records managers are employed in academic institutions. In a 2012 MARAC membership survey, 43.3% of respondents work at a college or university. The most recent A*Census Survey in 2004 revealed that 35.8% of archivists worked in academia, but the survey did not address tenure-track status. Although planning for A*Census II is underway, there is no current public data that accurately quantifies how many archives professionals work in academia or hold tenure-track positions.

Considering the absence of key metrics, this panel of four archivists will discuss the gaps in the professional literature and knowledge base as they relate to the following issues: 1) the availability of tenure-track archivist positions; 2) the standards, or lack thereof, by which tenure-track archivists are promoted and/or tenured; 3) the challenges and inequities experienced by tenure-track archivists; and 4) the importance of leadership and mentoring that support both tenured and tenure-track archivists throughout their careers. In addition, each panelist will offer ideas about new initiatives for improving advocacy for current and future tenure-track archivists. Information is a powerful ally in this pivotal work; furthering this research could lead to increased transparency in the tenure process for archivists and help to even the playing field for those who are traditionally marginalized in our profession.
