FROM THE CHAIR

Dear Colleagues:

It's December already, and four months since our August meeting in Austin. They've been busy months for the Section, and things will only get busier.

A few quick updates: in Austin, we welcomed a new Vice Chair, Tamar Chute (The Ohio State University) and a new SAA Council liaison, Tom Frusciano (Rutgers University). Since then, Heather Briston (University of Oregon) and Kevin Glick (Yale University) have joined our steering committee. Six session proposals were submitted to the steering committee for our consideration for endorsement. We recommended two (the maximum number allowed) to the Program Committee, and I'm happy to report that both of the sessions we endorsed were accepted.

At the Austin meeting, I presented three modest goals for the coming year which I believe will better position our Section for increased collaboration both within the C&UA group and with our SAA counterparts. The first goal is to conduct a review of our Section bylaws in the context of more recent SAA Guidelines for Sections.

There are some small but important discrepancies between the two documents which have significant impact on our operations. Our current bylaws, for example, call for a Section chair and vice chair, elected on alternate years, each serving a two year term. SAA's guidelines call for a chair/chair-elect system, along the lines of SAA's presidential elections. Other discrepancies have to do with appointments vs. elections. These small conflicts unnecessarily complicate life for an incoming chair, who needs to hit the ground running and is confronted with contradictory information. Any changes to the Section bylaws are voted on by the Section membership.

New guidelines call for implementation of electronic voting. Our second goal for the year is to position ourselves for the transition to online voting in the coming year.

Our third goal is to conduct an assessment of how our Section website and our Section newsletter work in tandem, determine if there are ways we could communicate more effectively, and develop recommendations for any changes.

I have asked our steering committee members to lead these initiatives, beginning with a review of the relevant documents, including a comment phase for member input, and concluding with recommendations for each of the initiatives. Recommendations will be shared with the membership in advance of the annual meeting in Washington DC in 2010. There will be a variety of ways to participate in these initiatives, either through comments to the Section listserv, participation in surveys developed to solicit feedback, or by contacting the steering committee members and officers directly to share your thoughts.

The small group leading the bylaws review consists of Kevin Glick, Heather Briston, Rachel Vagts. The small group leading the website and newsletter review is Jay Gaidmore, Maria Estorino, and Chris Prom. Tamar Chute will lead the effort to position ourselves for electronic voting. Please contact any of us with your thoughts and suggestions.

Finally, I want to extend my sincere thanks to our newsletter editor, Chris Laico, our webmaster, Claude Zachary, our outgoing vice chair John Bolcer and outgoing steering committee members, John Ansley and Mike Strom. You are a pleasure to work with.

Kentucky: New Online Resource Launched at the University of Kentucky Archives

The University Archives, University of Kentucky Libraries, announces the creation of a new online resource. Explore UK, <http://exploreuk.uky.edu>, which aims to preserve the memory of the institution and make university history more readily available. The University Archives collaborated with Digital Programs to expand the availability of historic items frequently requested by researchers, alumni, current students and faculty for the new online resource.

Explore UK brings together textual and visual records that can be browsed or keyword searched, it links to our flickr and Facebook pages, and allows for users to comment on photographs. Currently, the site offers more than 30,000 university related images, Board of Trustees minutes, yearbooks, and an expanded athletics section.
